# Summary of key findings for parents

## This provision is outstanding

- Children thrive in the childminder's care. She is exceptionally sensitive to their individual needs, recognising when they require reassurance and encouragement to try out new experiences.
- Since the last inspection, the childminder has continued with her strong commitment to improvement. She has a very reflective approach and correctly identifies how she wants to extend the opportunities for children who prefer to learn outside.
- Parents are very happy with the childminder. They make highly complimentary comments about her friendly and honest approach and about the rapid and sustained progress their children make at her setting.
- Children are safe in the childminder's home. They are very well supervised and are excellently supported to learn about how to keep themselves safe during their play and activities.
- The childminder is highly skilled in her teaching. She understands that children have different ways they like to learn and accommodates this successfully. Children respond eagerly to her highly positive, yet gentle involvement in their play.
- Children are very confident in the childminder's home. They know the flexible routines of the day and this ensures they feel safe and have a strong sense of well-being.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. The childminder demonstrates a very secure understanding of the procedures to follow in the event of child protection concerns. She has completed recent training that covers a wide range of aspects of safeguarding. Since the last inspection, the childminder has significantly increased her knowledge and understanding through relevant training. The extra knowledge has a highly positive impact on her awareness of safeguarding and her confidence to securely continue to protect children's welfare.

## Quality of teaching, learning and assessment is outstanding

Children thoroughly enjoy the childminder's skilled and highly positive involvement in their play. She uses very strong teaching strategies as she plays alongside children, demonstrating how things work and talking to them about what they are doing. She is extremely responsive to children's interests. The childminder recognises when children need reassurance to try out new activities and is aware how she can enable them to explore and be even more curious, especially outdoors. She provides an outstanding range of items in the water tray, including brushes and toy sea creatures which capture children's interest. This activity prompts lively conversation where children's vocabulary is expertly supported and extended. The childminder has an accurate, detailed understanding of children's next steps in learning and is highly successful in planning for each child's individual learning.

### Personal development, behaviour and welfare are outstanding

The childminder provides an extremely welcoming and friendly environment where children can choose from a great range of activities and resources. Children settle quickly when they arrive and the childminder has effective working partnerships with their parents. They know the routines of the day and are very confident to move between the inside and outside play areas. The childminder is highly effective in helping children to learn about healthy lifestyles. They develop, physical skills and an excellent awareness of the benefits of good personal hygiene. Children's close attachment to the childminder is clearly evident. They approach her for comfort, they listen to her, taking her by the hand to play with them. Children's behaviour is excellent because the childminder has a calm and consistent approach and children are able to become immersed in exciting activities.

#### **Outcomes for children are outstanding**

Children make rapid progress from their individual starting points. They are actively encouraged to be independent and are very well supported to build on what they already know. Children are very well prepared for moving on to school. They develop useful skills including sharing, considering others, and respect for others.
