Summary of key findings for parents

The provision meets requirements

- The manager has a clear understanding of requirements. Staff attend child protection training and know what to do should they have a concern about a child in their care. The manager has a clear awareness of the importance of monitoring the health and safety procedures and conducting robust risk assessments.
- The manager knows how to promote a welcoming environment where children's emotional attachments and positive behaviour are supported.
- The manager has a broad range of suitable toys and equipment in place for children and she understands the importance of promoting children's independence.
- The manager knows how to ensure that partnerships with parents and other professionals help to encourage children's care and development needs.
- The manager recognises how to put procedures in place to ensure that self-evaluation includes staff, parents and children, to help improve the provision.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector toured all indoor and outdoor areas of the premises where childcare is provided.
- The inspector held discussions with the manager about how she meets the requirements of the early years foundation stage.
- The inspector looked at policies and documents the manager uses when caring for children and held a discussion about the self-evaluation procedures and improvement plans.
- The inspector checked evidence of the suitability and qualifications of all staff working with children.
- The inspector held discussions with staff who were present at the time of the visit.

The Allsorts Club registered in 1994 and is operated by a voluntary management committee. It operates from a mobile classroom within the grounds of Cudsworth Primary School in Sutton Coldfield, West Midlands. The club opens Monday to Friday during term time. Sessions are from 7.50am until 8.50am, and 3.15pm to 6pm. The club employs five members of childcare staff. All staff hold appropriate early years qualifications at level 3 or above. At the time of this inspection, there were no children present.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
