The provision meets requirements

- The childminder has a thorough understanding of how to help children make good progress in all aspects of their development. She knows how to develop communication and language, physical and social skills for babies and young children.
- The childminder demonstrates knowledge of how to teach older children early reading, writing and numeracy skills in preparation to start school.
- The childminder has settling-in procedures to follow in order to help her get to know children. She understands how to work in partnership with parents, gathering information about children's specific care routines to meet their needs effectively and promote inclusion.
- The childminder has established and maintained effective partnerships with local schools and other professionals, such as health visitors. She demonstrates excellent knowledge of how to share information about children in order to promote continuity.
- The childminder has continued to use her self-evaluation effectively to maintain her skills and knowledge to work with children. She has up-to-date information about how to keep children safe and has maintained her first-aid qualification.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
