The provision meets requirements

- The provider understands her responsibilities to make the environment safe and secure for children. They know how to encourage children to follow the rules and to promote their positive behaviour.
- The provider knows how to provide a variety of play activities to support children's interests. They understand the importance of working in partnership with parents and other professionals to provide consistency for children's care.
- The provider understands the importance of supporting staff in their roles. She knows how to ensure staff have regular access to continuing professional development opportunities, including supervision.
- The provider knows how to support children's physical and emotional well-being. For example, she knows how key persons may meet children's needs and help them settle.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The club opens on Monday to Friday during some school holidays. Sessions are from 8.30am until 5.30pm. The manager and owner hold an appropriate early years qualification at level 3. There were no children in the early years age range on roll at the time of the inspection.
