Summary of key findings for parents

This provision is inadequate

- The childminder has a poor knowledge of the procedures to follow if she has concerns about children's welfare or the possible signs that could give cause for concern.
- The childminder does not have effective systems in place to observe or assess children's progress or a secure knowledge of their stage of development. She is unaware of any gaps in their learning or how to plan to provide further challenge in preparation for future learning or their move to school.
- The childminder has little knowledge of and does not complete the progress check for children between the ages of two and three years. She does not share information with parents about their learning or encourage them to share ideas to further support their development.
- The childminder does not adapt activities to ensure all children, especially younger children, can take part in creative activities.
- The childminder does not evaluate her practice effectively. She has not identified weaknesses in her practice or kept her knowledge and understanding of some legal requirements up to date.

It has the following strengths

The childminder meets children's care needs effectively and she provides them with reassurance and comfort. For example, she gives them cuddles.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is not effective. The childminder has an insufficient knowledge and understanding of the procedures to follow if she has concerns about children's safety, a lack of knowledge of recent changes in legislation and a limited knowledge of possible signs of abuse. The childminder communicates with parents regularly, however, she does not share information with them about their children's learning or how she is supporting their development. Self-evaluation is weak. The childminder does not evaluate her practice or include the views of parents or children to help her improve. She also does not keep required policies in line with current legislation.

Quality of teaching, learning and assessment is inadequate

The quality of teaching and learning is poor. The childminder does not have a sufficient knowledge of the learning and development requirements and, therefore, does not promote children's learning effectively or support them in making good progress. The childminder has little knowledge of children's stages of development and does not have effective systems in place to identify any gaps in their development. The childminder does not complete the required progress check for children between the ages of two and three years. Children are not challenged or motivated to learn. The childminder does talk to children while they play, however, she does not plan activities or extend their play ideas. This has a significant impact on their ability to make progress.

Personal development, behaviour and welfare are inadequate

The childminder has an insufficient knowledge of child protection procedures. This has a significant impact on children's safety and personal development. The childminder provides suitable care which helps support children's emotional well-being. However, children, especially babies, are not stimulated to learn or given the opportunity to engage in interesting learning opportunities. For example, when older children explore play dough, babies are kept away from the activity and not provided with alternative resources to promote their creative skills. Children behave appropriately. They listen to the childminder and clear away some toys when asked to do so.

Outcomes for children are inadequate

Children are not well prepared for future learning or their move to school. They do not make enough progress. Children are not challenged to learn or motivated to take part in activities to support their learning. Older children are happy and communicate their needs confidently. For example, they take themselves to the toilet.
