## Summary of key findings for parents

### The provision meets requirements

- The provider and staff have a good knowledge of the correct procedures to follow should they have concerns regarding children's welfare. Rigorous recruitment procedures are in place to ensure that staff are suitable for their role.
- The provider regularly reflects on the provision she offers. She actively seeks the views of staff, parents and children, in order to strive for continuous improvement.
- The provider has a sound knowledge of how to provide individual children with interesting and motivating activities that complement their learning in school.
- The provider works in partnership with parents, carers and teachers. She understands the positive benefits of sharing information.
- The provider has secure arrangements in place for children to build strong relationships with their key person and other members of staff, to help them to feel safe and secure.
- The provider and staff team continue to develop their knowledge and skills. They attend regular training, research new ideas online and read professional publications.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector discussed the safeguarding and welfare requirements with the provider and staff. She took into consideration the evidence of the suitability of staff working in the club.
- The inspector looked at the policies and procedures with the provider and viewed documentation that she uses when caring for children.
- The inspector toured the areas of the premises that are used by children and viewed the range of activities and toys available.
- The inspector reviewed how the club reflects on the service it provides.

Stevenage Play Learning & Activity Team Ltd registered in 2011. The club is situated in Ashtree Primary and Nursery School in Stevenage and is privately managed. It employs eight members of staff, three of whom hold appropriate early years qualifications at level 3 and above. The club opens from 3.10pm to 6.15pm, Monday to Friday during term time only.
