## Summary of key findings for parents

### The provision does not meet requirements

- Some staff do not demonstrate a good enough understanding of safeguarding. They do not demonstrate how they will confidently follow policies and procedures if they have concerns about a child or member of staff.
- Staff supervision is not effective enough to support, coach and raise the quality of staff's practice to a good level.
- Staff know the importance of planning an interesting range of activities. The play spaces are welcoming and safe. Staff know to allow children to make decisions about what they want to do. There is a wide selection of resources and activities available. Staff understand the need to supervise children well.
- Staff provide healthy snacks and promote healthy lifestyles. They understand the need to use positive strategies to promote good behaviour and teamwork. Staff are qualified in first aid.
- Staff understand the importance of working in partnership with parents and other professionals to ensure children's needs are met.
- An evaluation to identify strengths and areas for development has been completed, although this is not current.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

### To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

- The inspector checked evidence relating to the suitability of staff.

- The inspector held meetings with the provider and the manager of the club. The inspector sampled a selection of documentation, including safeguarding procedures, performance management and the club's self-evaluation record.

Schools Out Burbage registered in 2013. The club opens Monday to Friday, from 7.50am to 9am and 3.15pm to 5.30pm, term time only. There are three staff working directly with the children. All staff hold early years qualifications at level 3.
