Summary of key findings for parents

This provision is good

- The childminder knows the children well. She has a strong understanding of child development. She completes precise assessments of children, and tracks and plans for their progress well. Children make good, and in some aspects outstanding, progress in their learning and development.
- The childminder has an excellent understanding of the needs of children who have spent a full day in school. She understands that Reception-aged children are often tired at the end of the day. She provides a good range of play resources that links with their individual interests and encourages them to make their own choices.
- The childminder forms strong partnerships with parents. She keeps them fully informed about their children's progress and developing needs, and they work closely together to ensure children receive consistent support. Parents are delighted with the care the childminder provides and how happy children are to attend.
- The childminder promotes children's welfare exceptionally well. For example, children engage in active outdoor play after school in the garden, have a strong understanding about hygiene and enjoy healthy snacks.

It is not yet outstanding because:

■ The childminder effectively evaluates her provision. However, her professional development focuses on essential aspects of training, rather than being specifically targeted at developing first-rate teaching skills.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

build on the already good practice and use self-evaluation even more effectively to seek further ways to develop an expert knowledge of teaching and learning.

Inspection activities

- The inspector observed the childminder's interaction with children during activities indoors and in the garden. She looked at the childminder's range of play and learning resources and equipment, and observed the suitability of the premises.
- The inspector discussed the childminder's practice with her and the impact of her engagement with children.
- The inspector sampled a range of documentation, including children's records and the childminder's suitability. She also discussed the self-evaluation process.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder completes regular child protection training that covers wider safeguarding issues. She has a clear understanding of the procedures to follow if she is concerned about a child's welfare. The childminder completes thorough risk assessments of her home and for outings, and these effectively help to keep children safe. The childminder very recently attended a training day focused on 'talking to children' and is applying the strategies she learned from this exceptionally well. However, her focus for professional development centres more on safeguarding aspects. While this is important, not enough attention is given to building on her good teaching skills.

Quality of teaching, learning and assessment is good

The skilled strategies the childminder uses to encourage children's communication and language are impressive and effective. For example, as they sit together making Father's Day cards, she asks children if they are going to do anything special for their daddy. They think very carefully and decide to make their daddy 'a rocket'. The childminder challenges children further with questions that prompt them to plan exactly how they will make this and hide it until 'the day'. She recognises when children's concentration levels are wavering and steps in with enjoyable suggestions, such as 'Is it time for garden play?' The childminder has well-established and successful arrangements with the schools children attend. She shares good information which helps her to plan activities that complement the learning that takes place at school.

Personal development, behaviour and welfare are outstanding

Children are cared for in a highly welcoming, very well-resourced and safe environment. They are extremely happy, have a deep sense of belonging within the environment and form exceptionally strong emotional attachments with the childminder and her children. Behaviour is exemplary. The childminder has successfully addressed the recommendation raised at the last inspection. She now supports children to settle into her care exceptionally well. For example, she asks parents to provide photographs of children's immediate and extended family. The childminder uses them to create a special book for each child to browse through and share with her and other children. This helps children to feel very secure and a deep sense of belonging.

Outcomes for children are good

Children are well prepared for the next stage in their learning. They practise their early reading skills, for instance, as they search for lowercase letters using their developing knowledge of phonics in a tray to form the greeting 'happy Father's Day' when making cards. They develop high levels of independence and the confidence to express their views and ideas. Children are sociable and help each other overcome challenges.
