## Summary of key findings for parents

#### This provision is inadequate

- The childminder has not ensured she keeps up to date with changes to the early years foundation stage. Her knowledge of requirements is weak, leading to breaches of the Early Years Register and the Childcare Register.
- The childminder does not have a sound understanding of safeguarding matters. She lacks understanding of child protection issues, including all the signs that may indicate a child is at risk of harm.
- The childminder does not maintain confidentiality. Confidential information about children is sometimes shared inappropriately. In addition, the childminder does not keep the required record of the outcome of any complaints she receives.
- The childminder does not complete accurate observations and assessments of children's learning. She does not plan experiences that are matched to individual learning needs.
- The childminder does not have sufficient understanding of the required progress check for children aged between two and three years. She does not monitor children's development effectively to identify and close any gaps in learning. Children do not make sufficient progress.
- The childminder does not encourage older children to do things for themselves in order to develop their independence skills in preparation for starting school.

- increase opportunities for older children to do things for themselves to develop their independence skills
- improve the self-evaluation process to identify and address all weaknesses effectively and raise outcomes for children.

## **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The childminder has not placed enough focus on reviewing her provision to ensure she is up to date with current good practice. She has not identified or addressed key weaknesses in her knowledge and skills. Although she regularly meets with other childminders to discuss practice, she has not put in place the necessary changes to raise the overall quality of her provision to a good level. Safeguarding is ineffective. The childminder lacks knowledge of current safeguarding matters, including being alert to signs that children are at risk of being exposed to extreme ideas. The childminder does not keep a record of the outcome for any complaints she has received. She does not maintain confidentiality. This is because she sometime shares information about children with others who have no professional right or need for the information.

## Quality of teaching, learning and assessment is inadequate

Although the childminder is well qualified, she has a poor understanding of how to assess children's progress. She bases much of her assessment on what she thinks children should be typically doing at a certain age and not by using sound assessment processes. The childminder does not have a secure understanding of how to complete the progress check for children aged between two and three years. This affects her ability to tailor activities or experiences to meet their individual learning needs. Planned activities are based on what children like doing, with little consideration given to what they need to learn next. Although children find these activities enjoyable, they are not sufficiently challenged to help them make good progress towards the early learning goals. There are some suitable teaching strategies. The childminder promotes children's speaking and listening skills. For example, she asks older children questions and engages them in conversation. She encourages younger children to develop their physical skills. For example, they enjoy making marks using paints, fingers and brushes.

#### Personal development, behaviour and welfare are inadequate

Children's well-being is compromised due to the weaknesses in safeguarding their welfare. The childminder does not promote older children's independence skills consistently. For example, she gives them a spoon to eat their meals and cuts up food for them. Children are generally happy and settled. The childminder is kind and children form close bonds with her. Children generally behave well. Their health is suitably promoted through the provision of healthy meals, snacks and drinks. Children have opportunities to engage in physical activity through regular trips to the park.

#### **Outcomes for children are inadequate**

Children do not make sufficient progress. They are not motivated or encouraged to learn through purposefully planned, challenging activities. Older children do not develop their confidence or independence skills sufficiently. They are not encouraged to do things for themselves which they are capable of doing at their age. Children do not gain the skills they need in readiness for their future learning, including starting school.
