Summary of key findings for parents

The provision does not meet requirements

- The childminder does not effectively evaluate her practice. She has failed to identify breaches in requirements relating to the early years register and the both parts of the Childcare Register which compromise children's safety. Safeguarding is ineffective.
- The childminder does not obtain written consent to administer medication to children or keep records of when it has been administered. She does not record children's daily attendance or keep records of required information about all children in her care.
- The childminder does not inform parents of how to contact her in an emergency. She failed to make alternative arrangements when she was unavailable to collect children.
- The childminder has failed to notify Ofsted of changes to her health that may affect her suitability to care for children. It is a requirement to do so.
- The childminder does not have any fire control equipment to help keep children safe in her home in case of fire.
- The childminder knows how to plan activities that interest and challenge children and how to use observations to plan for their needs and future progress. She knows how to help children recognise their own feelings and behaviour and how it affects others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:
