Summary of key findings for parents

The provision meets requirements

- The childminder understands her responsibility to promote children's welfare. She is knowledgeable about safeguarding and knows the relevant procedures to follow if she has any concerns about children. The childminder attends regular training to help her update her knowledge.
- The childminder understands how to support children's learning and development. She has a good range of resources for children to help them play, explore and learn. The childminder knows the importance of planning activities to help children make progress in their learning, and to help prepare them to move on to school.
- The childminder understands the importance of working with parents and others involved in children's care. She knows how to promote a healthy lifestyle and encourage positive behaviour. The childminder recognises the importance of providing children with opportunities to learn about the diversity of the wider world.
- The childminder knows how to use reflection to help her identify her strengths and weaknesses, and make plans for ongoing improvements to her setting and practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she would observe, assess and plan to help children make progress in their learning.
- The inspector discussed with the childminder her understanding of safeguarding and what she would do if she had any concerns.
- The inspector sampled relevant documentation, including suitability checks.
- The inspector viewed areas of the house and garden used for childminding.
- The inspector took note of written views from parents.

The childminder registered in 2015. She lives in Botley, Hampshire. The childminder provides care Monday to Thursday, from 7am to 6pm, during school term time only. The childminder holds a recognised early years qualification at level 3.
