# Summary of key findings for parents

# This provision is outstanding

- Children thrive and flourish in the nursery. Staff promote children's personal, social and emotional development superbly. The highly positive and supportive atmosphere within the nursery fosters children's emotional well-being exceptionally well.
- Observations, assessments and planning are precise and sharply focused on each child's individual needs. Children enjoy taking part in exciting activities that challenge their learning. All children make excellent progress. For those children whose starting points are lower, gaps in attainment are closing rapidly.
- Partnerships with parents are superb. Staff have put in place a broad array of imaginative tailored support to engage parents. Parents really enjoy the ingenious oneto-one sessions they have with the staff to learn how to care for their child appropriately.
- Children's safety is central to everything staff do. They have exceptionally strong links with external professionals working with children to reduce the risk of harm and promote their welfare and education.
- A robust system for the observation of staff practice helps leaders to monitor the quality of teaching. There is an extremely strong and consistent emphasis on promoting staff's professional development. All staff are highly motivated and driven. This has a positive impact on all areas of the nursery.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

build on the already excellent monitoring of children's progress to help narrow achievement gaps even more rapidly.

### **Inspection activities**

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector spoke with staff and children during the inspection.
- The inspector completed a joint observation with the nursery manager.
- The inspector held a meeting with the nursery manager. She looked at relevant documentation and evidence of the suitability of staff working in the nursery.
- The inspector spoke to a number of parents during the inspection and took account of their views.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. Staff have an expert understanding of their role in protecting children's welfare and current legislation. They are extremely clear about the procedures to follow in the event of a concern about a child. Highly effective arrangements for the recruitment, vetting, regular supervision meetings and appraisal of staff are in place. All staff, parents and children are involved in actively reviewing and evaluating all aspects of the nursery. This ensures that actions for improvement are extremely well targeted and always highly ambitious. Children's progress is precisely assessed and monitored. Their individual needs are promptly addressed. Leaders have identified the need to give priority to making even greater use of data, in order to help narrow achievement gaps even more rapidly.

### Quality of teaching, learning and assessment is outstanding

Staff motivate children and ignite their thirst for early learning with their extreme passion and excellent teaching. The nursery environment is exceptionally well resourced, indoors and outdoors. It is organised to capture children's curiosity and promote their investigations. For example, toddlers show wonder and excitement as they explore shaving foam tentatively. They are self-assured and enjoy investigating a wide variety of mirrors and musical instruments. Babies confidently explore different objects in the environment, such as shiny scarves and colourful animal shapes. Staff provide parents with a multitude of ways to share information on children's progress. Parents are offered hands-on sessions, in which they learn about ways to support their child's learning and development at home.

## Personal development, behaviour and welfare are outstanding

The relationships between staff and children are exceptionally strong. Staff work on a one-to-one basis with each child. They have first-rate knowledge of children's individual needs and interests. This helps to expertly foster and monitor the emotional well-being of babies and children. Children benefit from a wide range of freshly prepared healthy snacks. Staff provide exciting opportunities for children to develop independence and experience physical challenge. Children's behaviour is excellent. Babies delight when taking part in massage sessions and hand-to-eye coordination activities. This helps them to feel calm and relaxed.

### **Outcomes for children are outstanding**

All children are making outstanding progress from their starting points. They are inquisitive, confident and motivated learners. Children make exceptional progress in their communication and language skills. They are remarkably well prepared for their move on to other settings when the time comes.
