Summary of key findings for parents

The provision meets requirements

- Since the last inspection, the childminder has addressed the actions raised and now meets the legal requirements. She has further evaluated her service and identified areas for future development. This demonstrates that she has the capacity to improve. She keeps up to date with training.
- The childminder understands her responsibility to promote children's safety and wellbeing and to protect them from harm. She knows the procedures to follow should she need to make a child protection referral. All areas used by children are safe and secure.
- The childminder knows how to observe, assess and help children to make progress from their starting points. She knows how to plan activities to engage children and help them to move on to their next stage of learning. She has a wide selection of resources.
- The childminder understands the importance of working in partnership with parents and other agencies or professionals.
- The childminder has considered how she will encourage positive behaviour, help children to respect and value others and create an inclusive environment.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to meet the safeguarding and welfare requirements when minding children.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning
- The inspector discussed record keeping and policies and procedures with the childminder and viewed the documentation she will use when caring for children.
- The inspector undertook a tour of the areas of the premises available for childminding.
