## Summary of key findings for parents

### The provision does not meet requirements

- Records are not correctly maintained and do not meet legal requirements. The provider has not recorded information about staff identity checks and vetting processes that have been completed.
- The provider has failed to ensure that there is a practitioner designated to take the lead responsibility for safeguarding within the club. This compromises children's welfare.
- The provider has not implemented a key-person system to ensure that each child's care is tailored to meet their individual needs.
- The provider has not put appropriate procedures in place to effectively support the supervision of staff and support their professional development.
- The environment is well maintained and well resourced. Children have the opportunity to access a range of resources.
- The provider understands the importance of promoting the health and safety of the children in her care. She has assessed and minimised the potential risks to children within the club. She talks about carrying out risk assessments to promote children's safety.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Rainbow Bright at Rushmere registered in 2004. It is managed by Rainbow Bright Day Nursery. The club employs five members of childcare staff. Of these, two hold appropriate early years qualifications at level 3 and two at level 2. The club opens Monday to Friday during school term time. Sessions are from 3.30pm until 6pm.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
