Summary of key findings for parents

The provision meets requirements

- The childminder is aware of the procedures to follow to safeguard children. She knows what action to take should she have any concerns about a child's welfare.
- The childminder knows how to plan interesting and challenging activities to support children's learning styles. She completes observations to plan for their future learning.
- The childminder recognises how to help children adopt positive attitudes to healthy eating and physical activity to support their overall well-being.
- The childminder understands how to promote children's positive behaviour. She understands the importance of setting clear boundaries and offering positive reinforcement.
- The childminder knows how to support children's understanding of similarities and difference between themselves and others to support their awareness of diversity.
- The childminder evaluates her practice and provision. She keeps up to date, for example, by reading current childcare guidance and subscribing to early years websites.
- The childminder understands the importance of working in partnerships with parents. She knows to establish children's starting points and support settling-in procedures.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and childminder discussed her knowledge of safeguarding, risk assessment, child development and self-evaluation.
- The inspector observed areas of the house used for childminding.
- The inspector discussed with the childminder how she evaluates her practice and plans for improvement.
- The inspector looked at a range of documentation relating to safeguarding, and the childminder's policies and procedures.

The childminder registered in 2015. She lives in Redhill in Surrey. She offers care from Monday to Friday, from 7am to 7pm, for most of the year.
