Summary of key findings for parents

The provision meets requirements

- The childminder understands how to keep children safe from harm. She knows the relevant procedures to follow should she have a concern about a child's welfare.
- The childminder has a secure understanding of the importance of working with parents and other professionals. She has given appropriate consideration to how she will foster effective relationships to provide consistency of care and learning for each child.
- The childminder has a good knowledge of the learning requirements. She has systems in place to monitor children's progress and to plan activities that help them to reach the next stage of their development.
- The childminder demonstrates that she knows how to promote children's well-being. She understands how to help children behave well and respect each other.
- The childminder knows how to evaluate her practice and plans to consult with parents and children to identify areas that may need to improve.
- The childminder understands the value of providing children with healthy routines, such as nutritious meals and snacks and daily opportunities for physical exercise.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the learning and development requirements for children.
- The inspector viewed those parts of the premises that the childminder intends to use for children.
- The inspector looked at evidence of the suitability of adults working and living on the premises.
- The inspector looked at the policies and documents that the childminder will use when caring for children.
- The inspector discussed how the childminder will evaluate her practice and how she plans to work in partnership with parents.

The childminder registered in 2015 and lives in Church Crookham, Hampshire. She provides care from 8am to 6pm on Monday to Friday, for most of the year. There were no children present in the early years age range at the time of the inspection
