Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- Key persons do not consistently make the best use of all opportunities to help children build on their relationships with them.
- Partnerships with parents and other settings that children attend require improvement. The management team does not consistently support a two-way flow of information with parents. The team has not developed effective procedures to share information with other settings that children attend.
- Monitoring of staff practice is not fully effective and there are inconsistencies in teaching practice. On some occasions children are not fully engaged and their learning is interrupted. Not all children make the best possible progress.
- Self-evaluation is not fully successful. Although the manager has identified most areas of weakness, improvement action is still in its initial stages and not fully effective.

It has the following strengths

- Children have opportunities to build on their physical skills. For instance, young children learn to crawl and walk and they explore while riding on play vehicles.
- Staff provide opportunities for young children to learn the meaning of words. For instance they introduce words such as 'scoop' and 'pour' and they use opportunities in children's play to model these actions.
- Staff encourage older children to share experiences that are special to them. For instance, children confidently sing songs to the group in their home languages and kindly state that they can 'teach' the song to others.

What the setting needs to do to improve further

Inspection findings

Effectiveness of the leadership and management requires improvement

The management team has not addressed all areas of weakness successfully, although it has made some improvement towards previous recommendations. The team does not always inform parents promptly of matters that affect their children's time at the setting or establish links with other settings that children attend. Teaching practice is inconsistent. Nevertheless, the manager supports individual staff and is taking some steps to address this issue. For instance, following training, staff have identified further ways to support children's free choice. The manager reviews individual children's progress and works in partnership with external professionals to help support staff to identify concerns for individual children's learning. Safeguarding is effective. Staff have an up-to-date knowledge of the nursery's policies and procedures relating to protecting children's welfare and know how to refer child protection issues. The management team ensures that there are adequate staff to care for the children. Overall, the provider takes appropriate steps to deal with complaints.

Quality of teaching, learning and assessment requires improvement

Some staff miss opportunities to challenge children effectively in their learning. For instance, during a book reading activity, they did not question older children skilfully or encourage their participation. They miss some opportunities to identify occasions when children are not engaged and to redirect them to enjoyable play experiences. Nevertheless, overall, staff take account of individual children's learning styles and plan appropriate next steps in their learning. They provide opportunities for babies to get to know each other. For instance, they choose a 'helper' to hand out the water beakers and make use of this opportunity to help them learn other children's names. Staff encourage older children to build effectively on their understanding of the world, for instance, as they go on visits to the local supermarket.

Personal development, behaviour and welfare require improvement

Key persons do not support children well enough to help them build consistent relationships. For instance, they hand over responsibilities, such as nappy change and feeding routines, to other staff and do not make the most of all opportunities to interact with the children. Nevertheless, overall, staff meet children's personal needs appropriately and supervise them effectively to ensure their safety. Staff support children's independence at mealtimes. For instance, older children learn to serve food onto their plates. Appropriate arrangements are in place to record information relating to accidents, incidents and medication, and the management team reviews these regularly to identify any patterns and to plan improvements. The team completes regular risk assessments and take necessary steps to minimise hazards to children's safety.

Outcomes for children require improvement

Children are not consistently engaged in activities due to the variable quality of teaching. Nevertheless, they generally behave well and learn to take account of the needs of others. Overall, they develop a range of skills in readiness for school.

Under the Willow Nursery registered in 2012. It is located in Dulwich, London. The nursery operates Monday to Friday from 7.30am to 6.30pm. It is open all year round, except for a week at Christmas and on public holidays. The nursery receives funding for the provision of free nursery education to children aged three and four years. The provider employs 16 staff. Of these, 11 staff hold relevant childcare qualifications at level 3 or above; one of whom holds qualified teacher status.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
