The provision does not meet requirements

- Staff do not record the hours of children's attendance, as required. This is also a requirement of the Childcare Register.
- The management team has good partnerships with the primary school. Managers understand the importance of working closely with teachers, including the school's Special Educational Needs Coordinator, to fully support children's individual needs.
- Managers understand the importance of working closely with parents to help young children settle when they first start attending the club.
- The management team has a good knowledge of how to identify and report child protection concerns, to help protect children's welfare.
- Managers know how to reflect on their practice and ask parents and children for their feedback, to help them improve children's experiences.
- Managers have a good understanding of how to support healthy lifestyles, such as encouraging children to play physical games and eat nutritious meals.
- The management team understands the impact of staff training. For example, managers identify training needs to help staff plan activities that will interest children and build on their physical skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Fit For Sport At Bishop Gilpin CofE Primary School registered in 2015. It operates from Bishop Gilpin CofE Primary School in Wimbledon, in the London Borough of Merton. It operates Monday to Friday, from 3.30pm until 6.15pm, term time only. A holiday club operates Monday to Friday, from 9.30am until 4.30pm, with the offer of additional care from 8.30am to 9.30am and 4.30pm to 5.30pm. The provider employs seven staff. Five members of staff have relevant qualifications at level 1 or above. Of these, one member of staff holds a qualification at level 6. There were no early years children present at the time of inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
