### Summary of key findings for parents

### The provision does not meet requirements

- The childminder is not familiar with child protection procedures. She does not keep up to date with current safeguarding guidance and does not fully understand her responsibility to protect children's welfare. For example, she does not know what to do if an allegation is made against her or a member of her household.
- The childminder understands the importance of her involvement in children's play. For example, she knows how to support children's interests, develop their independence and provide them with challenge.
- The childminder understands the importance of using observation and assessment to help children make the best possible progress from their starting points, and develop the skills they need for future learning, including starting school.
- The childminder understands the importance of involving all children within activities. She knows how to promote children's social skills and friendships.
- The childminder is committed to working in partnership with parents to meet children's individual needs. She understands the importance of creating effective communication with parents and involving them to promote continuity of care and learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
