Summary of key findings for parents

This provision is inadequate

- There are no staff with valid first-aid qualifications.
- Staff and the manger do not have a secure understanding of current child protection issues and guidance.
- The provider has not made sure that appropriate insurance is obtained prior to transporting children in a vehicle.
- The provider does not ensure that staff understand the importance of keeping information and records secure and confidential when they are off the premises.
- The key-person system is not effective to ensure staff consistently meet children's needs. Staff have not developed a good flow of information with parents and teachers to enable them to complement and build on the experiences that children receive elsewhere. They do not provide a wide enough range of activities and experiences that matches the interests and needs of children.
- The provider does not effectively evaluate and monitor the club's practice to ensure that the legal requirements and children's individual needs are met.

It has the following strengths

- Staff are friendly and work well together as a team. Children enjoy the time they spend at the club.
- Staff lock all external doors and there is a closed-circuit television system in the club. Children play in premises that are secure and safe.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

To further improve the quality of the early years provision the provider should:

strengthen the evaluation of the club and monitoring processes so that all weaknesses are highlighted and swiftly addressed to further raise standards.

Inspection activities

- The inspector observed the quality of experiences that children receive, both indoors and outdoors.
- The inspector spoke to the children and staff at appropriate times during the inspection.
- The inspector held a meeting with the manager and provider. She looked at relevant documentation and evidence of the suitability of staff working in the setting.
- The inspector spoke to parents during the inspection and took account of their views.
- The inspector completed a joint observation with the manager.

Inspection findings

Effectiveness of the leadership and management is inadequate

Self-evaluation is weak. The provider has not ensured that they continue to meet the requirements. The arrangements for safeguarding are not effective. The provider has not ensured that least one member of staff is qualified at all times to administer first aid, both at the setting and on outings. Children's well-being and welfare are compromised. The manager often transports children to and from school in her car; however, she has not ensured that she has suitable insurance to do so. Some documentation is not appropriately stored confidentially when taken out of the club by staff. Overall, most staff are generally aware of some indicators of abuse and neglect. They are aware of the setting's procedures to report any concerns they may have about children in their care. However, staff lack knowledge of wider child protection issues and signs which would alert them that children may be at harm from extreme views and behaviours. Suitable recruitment and supervision procedures ensure that staff's ongoing suitability is checked.

Quality of teaching, learning and assessment is inadequate

The key-person system is not established. The provider has not clearly assigned a key person to ensure that children's individual needs are met. Parents are not aware of their child's key person. Staff have not established effective communication links to share information with the schools where younger children attend. Staff are not able to tailor activities to meet children's needs and build on what they already know and can do, in order to complement their learning elsewhere and meet their interests. Children take part in some planned activities that are on offer, such as team games. Staff and children engage in discussion. This helps to develop children's confidence and communication skills. Parents say that they are happy with the activities the club provides and the positive relationships they have with the staff.

Personal development, behaviour and welfare are inadequate

Weaknesses in leadership and management mean that children's welfare and well-being are compromised. The provider has not ensured that there is a member of staff available at all times who is qualified to administer first aid. She has not ensured that records are stored securely when taken off site to maintain children's confidently. Children do have a secure attachment with the staff, although they do not always know who their key person is. Staff collect children from different schools and enable them to build friendships with other children. Children behave well. Staff remind them to follow behaviour rules that the children themselves have put together. Children are sociable and polite to others and are keen to share their views about the club. Their independence skills are suitable supported. For example, children volunteer to put cutlery and glasses on the tables and tidy up after they have eaten.

Fun Club registered in 2010. The club employs four members of childcare staff, all of whom hold an appropriate early years qualification at level 3. The club opens from Monday to Friday, during term time only. Sessions are from 7.30am until 8.50am and from 3.15pm until 6pm.
