Summary of key findings for parents

This provision is good

- Children enjoy the broad range of activities on offer and make good progress in their learning and development.
- Staff support children's language development well. For example, they ask effective questions and give children time to think of their answers to respond.
- Staff work in partnership with parents to shape the service they provide. They gather parents' views and use these to make changes to their practice. Recent changes include improvements to the outings offered to children. These help to support their understanding of the wider world in which they live.
- Children have an active voice in the nursery. Staff ask the children their views on activities they wish to play, helping to develop their confidence.

It is not yet outstanding because:

- Staff do not always take children's interests into account as well as possible when planning activities, to help to aid their learning.
- At times, staff do not extend activities to support children that are most able with their learning and development.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- develop further the planning arrangements to take more account of children's individual interests
- support staff to know when to extend activities further to offer more challenge for the most able children to develop their learning and development as fully as possible.

Inspection activities

- The inspector observed the children in the main play areas.
- The inspector spoke with the provider, staff and children at appropriate times during the inspection.
- The inspector carried out a joint observation with the provider.
- The inspector gathered the views of the parents.
- The inspector sampled documents, including children's learning files and staff suitability documents.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The provider and staff have a clear understanding of what procedures to follow if they have any concerns with children's welfare. The provider works closely with the local early years team to improve practice in the setting. Recent changes have been made to the tracking of children's learning. This has helped the provider to review any gaps in children's learning and to work with staff to reduce these. The provider reviews staff practice to help improve care of the children. Recent training has helped staff to support children with their language delay, narrowing any gaps in their development.

Quality of teaching, learning and assessment is good

Staff work closely with parents to assess children's starting points. Overall, staff are successful at planning activities that children enjoy and that help them to progress well. Children enjoy developing new skills, such as learning how to climb the 'A' frame. Staff support the children to work out how to move their hands and feet in order to climb over the top. Staff also teach the children about their own safety when using the climbing frame. For example, they remind children that they need their hands free so they can hold on tight as they climb.

Personal development, behaviour and welfare are good

Children develop good independence skills. Younger children learn how to use serving spoons, helping to support their physical development. Children build good bonds with the staff. They quickly settle, ready to start their learning. Staff find out about the children's backgrounds and teach them about different festivals and celebrations. Staff are consistent in their approach to behaviour management. They work together to teach the children the importance of sharing and taking turns. Children behave well.

Outcomes for children are good

Children are ready for the next stage of their learning. They develop good literacy skills. They enjoy spelling out their names and sounding out letters. Children learn about mathematics during everyday activities. For example, they count the rungs of the ladder as they climb, learning how to count in sequence. Children also develop good physical skills. They enjoy playing with water and learning how to empty and fill different-sized containers.
