Summary of key findings for parents

The provision meets requirements

- The manager knows how to minimise potential risks and maintain ratios to support children's safety. The environment is safe, clean and fully resourced.
- The manager has a secure understanding of her responsibilities to safeguard children, which includes how to report concerns regarding children's welfare.
- The manager knows how to coach, supervise and train staff to support them in their role and help them raise the standards of care and learning for children.
- The manager recognises the importance of building effective partnerships with parents and professionals to meet children's needs and their learning experiences.
- There are strategies in place to manage children's behaviour in positive ways.
- The manager demonstrates a good understanding of how children learn. She knows how to assess and plan for children's learning to help prepare them in readiness for school.
- The manager and provider have addressed the recommendations set at the last inspection to improve the quality of teaching. The manager demonstrates commitment to continually improve practice and identify priorities for further improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the manager about the practices and procedures, including safeguarding arrangements and how they deliver the educational programme for children.
- The inspector went on a tour of the nursery with the manager and discussed safety arrangements.
- The inspector looked at samples of documentation, which included the risk assessment and safeguarding procedures, assessment reports, training certificates and the public liability insurance certificate.

Tamba Day Nursery registered in 2014. It is situated in Chadwell Heath, in the London Borough of Redbridge. The nursery opens Monday to Friday from 7.30am to 6.30pm, all year round. The provider is in receipt of funding for the provision of free early education to children aged two, three and four years. The provider employs 14 members of staff. Of these, 13 staff hold appropriate early years qualifications from level 2 to level 6.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
