Summary of key findings for parents

The provision meets requirements

- The childminder understands of how to keep children safe in her home. She knows who to contact if she has concerns about the welfare of any child in her care.
- The childminder knows how to complete assessments of children's learning and monitor their development. She is aware of the need to offer a wide range of activities and resources that supports children to make progress and helps them develop skills they need for starting school.
- The childminder understands the importance of working in partnership with parents and other settings to provide a consistent approach to children's care and learning.
- The childminder knows how to support children's physical and emotional well-being. For example, she understands the benefits of active play in the fresh air and supports children to learn about eating healthy foods.
- The childminder evaluates her service and has a clear plan about how she can develop her knowledge and skills to support younger children in the future.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the parts of the childminder's home that she uses when caring for children.
- The inspector sampled documentation, including the childminder's qualifications, evidence of her suitability and accident reporting.
- The inspector assessed the childminder's understanding of how to keep children safe.
- The inspector spoke to the childminder to determine her knowledge of the early years foundation stage requirements.

The childminder registered in 2009 and lives in Ruscombe, Berkshire. She operates Monday to Friday from 7.30am to 6pm, all year round. The childminder holds a relevant childcare qualification.
