Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder has not fully eliminated risks to children, such as from inedible berries on plants in her garden.
- The childminder does not make the most of the extensive range of resources and good amounts of space available for children to use. Opportunities to play and learn are limited.
- The childminder does not always use good teaching skills or provide appropriately challenging activities that are matched to children's needs. She does not routinely extend children's learning and development.

It has the following strengths

- Children enjoy playing in a friendly environment where they feel happy and comfortable. They develop close relationships with each other and with the childminder's family. They are prepared reasonably well for the next stage of their education.
- The childminder actively seeks the views of both parents and children. They comment positively about the care she provides.
- Children benefit from many outings around the local area. This supports their understanding of the world and develops their social skills.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

Inspection findings

Effectiveness of the leadership and management requires improvement

Safeguarding arrangements are effective. The childminder understands her responsibilities regarding child protection. The childminder has taken some action to remove inedible berries on trees in the garden by cutting down branches. However, berries have fallen on to play equipment and to the ground and were accessible to children. The childminder supervises children well but these hazards in the garden compromise their safety. The childminder reflects on her practice and attends further training to enhance her knowledge. There are many resources in the childminder's home, divided into those for older and younger children. However, children cannot always access these easily to support their own learning. For example, a few peg puzzles for toddlers are put out on the floor but others are kept in a lidded box at the back of the dining table, inaccessible to the younger children. Partnerships with parents are strong. They receive a lot of information about activities and how the childminder cares for their children.

Quality of teaching, learning and assessment requires improvement

Children play and explore well together. The childminder uses topics to underpin the planning and activities she provides. She observes the children regularly, monitoring their progress right from when they come in to her care. This helps her to know how well they are doing. At times, the adult-led activities are not planned and adapted well enough for differing age groups or children's specific learning needs. This results in activities that are too challenging for the youngest children. The childminder questions children to stimulate discussion and extend their communication and language skills. However, she often quickly answers her own questions and children do not have enough time to think and speak.

Personal development, behaviour and welfare require improvement

The children behave well and respond positively to requests from the childminder. They take turns, use good manners, listen to their friends and show compassion towards each other. This promotes their personal, social and emotional development well and introduces them to British values. At meal times, children learn skills such as working together and cutting food safely as they help to prepare a nutritious lunch. Although the childminder has not made her garden completely safe, on outings, she teaches the children important messages such as road safety and about strangers. This helps them learn how to keep safe.

Outcomes for children require improvement

Children are making progress appropriately in line with their age and expected stage of development. The childminder assesses progress across the areas of learning for each child and shares this information well with parents. Children are inquisitive and show imagination and curiosity as they play. Children demonstrate good physical skills when playing with a spray water bottle and balancing toy eggs on spoons. They show keen team spirit and sound levels of personal development as they encourage one another during a sports day activity.
