Summary of key findings for parents

This provision is good

- The childminder offers a welcoming, well-organised home environment for children. They easily choose from a broad range of resources inside and outside in the garden.
- Children are happy and settled in the childminder's care. She has warm, caring relationships with children. She gets to know them well and is sensitive to their individual needs.
- The childminder plans a wide variety of interesting experiences that are well matched to children's interests, age and needs. Children are eager to take part and motivated to learn. They make good progress in their development from their starting points.
- There are positive relationships with parents. The childminder keeps them well informed about children's care and achievements. She successfully involves parents in their child's learning, for instance, she offers suggestions for activities to continue at home.

It is not yet outstanding because:

- The childminder does not work as closely as possible with all of the other early years settings that children attend, to help develop a shared approach to children's learning.
- The childminder does not make full use of opportunities to develop her knowledge and skills even further, to help raise the quality of children's experiences to a higher level.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- improve the partnerships with the other early years settings that children attend, to help develop a more consistent approach to children's learning and care
- make further use of opportunities to develop knowledge and skills, to help continually raise the quality of the provision.

Inspection activities

- The inspector observed children taking part in activities with the childminder and assessed the impact this has on their learning.
- The inspector had discussions with the childminder about her practice and children's learning and development.
- The inspector looked around the areas of the home used by children.
- The inspector sampled paperwork, including children's records.
- The inspector read comments from parents and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder has a good understanding of her responsibilities towards the children in her care. She knows how to recognise and report any concerns about a child's welfare or well-being. The childminder is vigilant about keeping children safe. She checks her home thoroughly each day to help identify and remove any hazards and supervises children closely at all times. The childminder reflects on her practice and identifies areas to improve. For instance, since the previous inspection she has updated the equipment in the garden to offer new challenges to children. She regularly seeks the views of parents to help her evaluate the provision.

Quality of teaching, learning and assessment is good

The childminder gathers detailed information from parents about children's needs and achievements before they start. She monitors children's progress closely and effectively identifies any areas where they are doing well or may need more support. She includes all children well. For example, children of different ages drew designs for their model together and the childminder supported them sensitively according to their needs. She successfully encourages children's language and communication skills. For instance, she extends conversations and gives children time to express their ideas. The childminder responds to children's interests well, such as making sure plentiful resources are available to help children extend their imaginative games.

Personal development, behaviour and welfare are good

The childminder is a good role model. She is calm and patient, and offers children gentle guidance and praise. Children behave well. They learn about people and communities outside of their immediate experience. For instance, they taste food from different countries and celebrate special events from home. The childminder supports children's good health well. For example, they develop a good understanding of good hygiene routines, and go and wash their hands independently after stroking the childminder's pets. The childminder helps children learn to keep themselves safe, such as taking part in regular fire drills. Children enjoy playing outside every day. They practise their physical skills on the play equipment and benefit from the fresh air and exercise.

Outcomes for children are good

Children develop strong social skills and play well together, sharing and taking turns with equipment. They are assured communicators. They express their ideas and recall previous events during conversations with their friends. Children grow in independence, helping themselves to toys and play materials. They count and solve problems as they play, working out the best way to build a tower with the blocks. Children practise their early writing skills and begin to recognise the sounds that letters make. They quickly gain the skills they need for their future learning and for the move to school.
