Summary of key findings for parents

The provision meets requirements

- The childminder recognises the importance of working in partnership with parents and involving them in children's learning, to help children progress.
- The childminder has suitable resources for children of different ages and stages of development. She knows how to monitor children's progress, for example, through observation and assessment. She understands the importance of self-evaluation.
- The childminder understands her role and responsibility in keeping children safe. She has a clear knowledge of safeguarding and knows the procedure to follow to report any concerns regarding the welfare of a child. She knows the importance of providing a safe and secure home environment for children.
- The childminder knows how to support children in learning about healthy lifestyles. For example, she knows how to teach children about hygiene routines and the importance of exercise to help support their physical development.
- The childminder knows how to manage children's behaviour and to help them learn to share and consider the needs of others. She understands her role in helping children to respect and value others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes of the early years foundation stage.
- The inspector viewed the areas of the premises that will be used for childminding and discussed safety arrangements.
- The inspector discussed with the childminder her system for self-evaluation.
- The inspector looked at samples of documentation and records that the childminder will use to support children's welfare and learning.
- The inspector discussed with the childminder how she will work in partnership with parents and professionals.
