## Summary of key findings for parents

## This provision is outstanding

- The childminder is extremely well organised and demonstrates a highly strong, passionate drive to continually improve the provision. Together with her co-childminder, she continually reviews and updates her practice and has an ambitious vision for the future.
- Children benefit from a highly stimulating indoor and outdoor environment that is rich, varied and inviting. They choose from a wealth of high-quality resources and show extremely high levels of confidence and independence.
- The childminder provides excellent individual support for children that is highly successful in encouraging their learning. Children are delighted to take part in an extensive range of exciting experiences based on their interests and needs. They make rapid progress in their learning from their starting points.
- There are highly successful partnerships with parents. The childminder involves parents in children's learning exceptionally well. For instance, she provides extremely well-planned activity packs for parents to borrow and take home.
- Children have excellent relationships with the childminder. She knows the children exceptionally well and is extremely responsive to their individual needs. Children flourish at the setting.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The childminder is highly reflective and makes excellent use of all opportunities to further extend her knowledge and skills. For example, she has used ideas from conferences and visits to other settings extremely effectively to further enhance how she supports children when they move on to school. She constantly reviews and makes changes to the setting that have an excellent impact on children's experiences. For instance, the outdoor area has been extended to offer children an extensive variety of new, interesting and challenging outdoor learning experiences. Safeguarding is effective. The childminder makes thorough checks of the assistant to help make sure they are suitable for their role and closely monitors and supports their performance. She has a comprehensive understanding of how to recognise and report any child protection concerns.

## Quality of teaching, learning and assessment is outstanding

The childminder monitors the learning programme and children's progress extremely effectively and very quickly identifies any gaps in teaching or areas where children need more support. She builds on spontaneous learning and children's interests highly skilfully and provides a wealth of excellent experiences that inspires children and motivates them to learn. For instance, children were fascinated to discover that the flowers they collected during a walk could be made into a drink. The childminder made exceptionally good use of the opportunity to build on this learning even further, such as sending recipe cards and ingredients home so that children could repeat the activity with their parents.

#### Personal development, behaviour and welfare are outstanding

The childminder and her co-childminder are excellent role models. They are calm, caring and offer children warm reassurance and praise. Children's behaviour is extremely good. They show concern for their friends and eagerly take responsibility for making sure everyone has a cup at snack time, checking what colour they would like. Children have excellent opportunities to learn about the backgrounds and experiences of their friends and reflect on their differences, such as visiting a Chinese restaurant for a meal. They show a very good awareness of safety, for instance, they learn to use real tools and equipment carefully during activities. The childminder is considering ways she can extend this understanding even further.

## **Outcomes for children are outstanding**

Children are enthusiastic learners who show high levels of curiosity and imagination. They develop excellent social skills and confidently negotiate and cooperate with their friends. Children are highly independent and even the youngest children confidently help set out the table for snack time. They develop extremely good physical skills. They enthusiastically practise their early writing skills, such as making their own books. Children show an excellent understanding of shape and size, and are delighted to make complex patterns using sponges. They rapidly gain the skills they need for their future learning and the move to school.
