Summary of key findings for parents

The provision meets requirements

- The provider understands the importance of using self-evaluation to identify and target priorities for improvement. The action and recommendations of the last inspection have been met. For example, the outdoor play area has been redeveloped.
- The provider implements robust staff recruitment procedures and understands the importance of providing staff with good professional development support.
- The provider is clear about her responsibility to keep children safe and to act on concerns about their welfare. She keeps up to date on changes in the law, for example, regarding car seats, and takes prompt action to follow guidelines.
- The provider has a wide range of good-quality play resources that is suitable for children aged four years and above to enjoy. The provider understands the importance of promoting healthy eating and for providing children with fresh air and exercise.
- The provider recognises the benefits of working in partnership with parents and children's teachers, to ensure children receive consistent support.
- The childminder understands how to help children develop positive behaviour.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the provider about how she met the recommendations and actions of the last inspection when early years children were attending, and how she intends to support the development needs of this age group in the future.
- The inspector looked at relevant documentation, including those relating to safeguarding procedures and the provider's procedures for recruiting and retaining suitable staff.
- The inspector checked the suitability of the premises, arrangements for transporting children from school to the club and the play resources.

Kool 4 Kids After School Club registered in 2011. It is privately owned and operates from a community hall in Coulsdon, within the London Borough of Sutton. The setting provides an after-school club between 3.15pm and 6pm each weekday during term time, and a playscheme that opens between 8am and 6pm during some school holidays. There are currently four members of staff, including the provider, and they all have childcare qualifications at level 3.
