## Summary of key findings for parents

## This provision is good

- The owners make targeted improvements to the nursery that have a positive impact on the experiences of children. They are supported in this by a dedicated and knowledgeable manager.
- A wide range of stimulating and easily accessible resources is available to the children. Staff support children's confidence in choosing activities that reflect their current interests.
- Staff are enthusiastic and motivated. They sensitively nurture children's emotional well-being. For example, staff create an atmosphere which parents describe as 'warm, like a home from home'.
- Assessment of children's progress is detailed and accurate. Staff effectively target children's learning to support them in making good progress and help them to catch up where necessary.
- Staff are skilled in observing and listening to young children. They give children time to think about and use their own words to express their ideas.

# It is not yet outstanding because:

- Occasionally, staff do not make the best use of opportunities to show younger children how to use resources appropriately, to extend their learning.
- Staff do not explore the most effective ways to offer parents information about their children's learning and to support them to extend it further at home.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

- provide consistent guidance for children to help them understand how to use resources appropriately, to further support their learning
- devise highly effective ways to share information with parents and support them to extend their children's learning at home.

### **Inspection activities**

- The inspector observed a range of activities, including outdoor play.
- The inspector undertook a joint observation with the manager.
- The inspector held a meeting with the manager.
- The inspector looked at some policies, children's records and documents relating to the suitability of staff, and discussed self-evaluation with the manager.
- The inspector talked to staff, children and parents to gather their views.

# **Inspection findings**

### Effectiveness of the leadership and management is good

Safeguarding is effective. The manager ensures that staff are confident in their understanding of the signs and symptoms which may give cause for concern about a child's welfare. Staff understand the procedures to follow if they have concerns. They have completed relevant training about how to identify any children who may be at risk of being exposed to extreme ideas or behaviours. The manager is supportive of staff professional development, providing regular training and supervisory meetings. Staff use the information gained through training effectively, for example, to introduce new activities tailored to support children who have special educational needs and/or disabilities. This helps staff to improve outcomes for all children.

## Quality of teaching, learning and assessment is good

Staff are skilled at enriching activities to capture children's interest and imagination. Children enjoy acting out their favourite stories as plays and performing them to staff and parents. Children successfully use their problem-solving and thinking skills. For instance, they explore exotic fruits and make predictions about what colour there will be inside. Staff successfully nurture children's physical development. For example, children learn to climb and manage their own risks safely in a soft-play area. Imaginative play is used effectively by staff to support learning. For example, children and staff build a train together from large construction bricks and pretend to travel to different places. Children laugh with delight as they make train sounds for their game.

#### Personal development, behaviour and welfare are good

Staff support children's social skills well. Children are excited to play together and describe one another as 'friends'. Children learn about adults who help to keep them safe and well. They receive visits from a dentist, a doctor and firefighters. Staff help children to learn about people whose experiences might be different to their own. For example, they find out about different festivals with the support of parents. Staff are polite to each other and are very good role models for the children. Children build secure relationships with staff and turn to them for help and support, if needed.

#### **Outcomes for children are good**

Children behave well and are engaged, motivated learners. They confidently use their communication skills to hold detailed conversations with adults. For example, they talk about having new clothes to wear which they describe as 'comfortable'. The youngest children experiment with colour as they paint their hands to make prints. Children play shops, examine vegetables and use mathematical language, such as 'big' and 'heavy'. They use their emerging writing skills to write their own names. Staff prepare children very well for the next stage of their learning, particularly school.

Stepping Stones Nursery registered in 2013. The nursery is open Monday to Friday from 7.30am to 6pm, for 51 weeks of the year. There are 10 members of staff, five of whom hold relevant early years qualifications at level 2, 3, 4 or 6 and two hold qualified teacher status. The nursery receives funding for the provision of free early years education for children aged two, three and four years.
