- The childminder has recently updated her safeguarding knowledge and understands her responsibility in protecting children to help keep them safe.
- The childminder recognises the importance of working in partnerships with parents, other professionals and settings that children attend, to provide continuity for children.
- The childminder understands how to promote children's well-being. She provides children with a choice of healthy snacks and daily fresh air and exercise.
- The childminder knows how to help children to manage and learn about their own feelings and behaviour. She understands how to explain boundaries and expectations.
- The childminder has an extensive range of toys and equipment that covers all areas of learning. The resources are readily available for children to select independently.
- The childminder works closely with the local authority to reflect on her provision. This helps her to ensure her skills, knowledge and procedures are up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
