Summary of key findings for parents

The provision meets requirements

- The childminder understands how children learn. She describes a range of different activities that she plans to do to help children develop essential skills and attitudes.
- The childminder knows how to promote children's safety and welfare. She has completed child protection training and keeps up to date with changes in safeguarding legislation.
- The childminder understands the value of sharing information with parents and other settings that children may attend to ensure continuity in children's care and learning.
- The childminder intends to teach children to respect one another and be tolerant of other's beliefs. She is aware of how to implement positive behaviour management strategies.
- The childminder understands how to promote children's health and well-being. She plans to provide nutritious meals and regular opportunities for children to exercise.
- The childminder understands the importance of reflecting on her practice to help her identify and plan for future improvements, to improve outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas of the premises used for childminding.
- The inspector discussed with the childminder her knowledge of safeguarding, risk assessment and self-evaluation.
- The inspector reviewed the resources and talked to the childminder about how she intends to deliver the educational programmes when caring for young children.
- The inspector looked at a range of documents. These included evidence of the suitability of all adults living and working on the premises, a record of the childminder's training, policies and procedures.

The childminder registered in 2012 and lives in Macclesfield, Cheshire. She operates all year round, from 8am to 7pm, Monday to Friday, except for bank holidays and family holidays. The childminder holds a childcare qualification at level 3.
