# Summary of key findings for parents

# This provision is good

- The provider, manager and staff are passionate in their commitment to provide a high-quality learning environment for children. They work very well as a team, which helps to provide a welcoming and happy atmosphere within the nursery.
- The quality of teaching is good. Staff regularly attend training, which has a positive impact on the learning experiences they offer for children.
- The outdoor environment has been imaginatively developed to include all areas of learning, to support children who learn best outside.
- Children take part in many charity events which help them to respect others and contribute to the wider society.
- Children who speak English as an additional language are supported well in using their home language as well as in learning to speak English.
- Staff are excellent role models who show a great deal of warmth and affection for children they care for.
- Parents speak highly of the staff team and the good service they receive. Staff develop very good relationships with parents and regularly exchange information with them and keep them fully informed about their children's care and progress.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- strengthen arrangements for sharing information with other early years providers that children attend to enhance the consistency of their learning and development.

# **Inspection findings**

## Effectiveness of the leadership and management is good

Safeguarding is effective. All staff understand their responsibilities to protect the children in their care and know the procedures to follow if they have any concerns. Recent training has strengthened staff's understanding of the latest guidance on keeping children safe. Children's absences are carefully monitored and staff promote good attendance. Safer recruitment procedures and suitability checks are carried out appropriately. The manager and staff ensure that children's safety is given the highest priority. The premises are safe and secure and children are supervised very well. The management team are reflective and continually evaluate the provision they offer. Staff and management monitor children's progress regularly, and any gaps in their learning are quickly identified and addressed.

## Quality of teaching, learning and assessment is good

Children enjoy many exciting activities and play opportunities, which are linked to their individual needs and interests. Staff interact well with the children, supporting and promoting their communication and language skills. They play alongside children and extend their vocabulary. For example, the words 'stomp', 'explode' and 'volcano' are introduced during an activity where children pretend to be dinosaurs. The activity also introduces numbers and counting, helping to support children's mathematical development. Babies and toddlers have many opportunities to enjoy stories, rhymes and songs. Children use a variety of tools when making marks. For example, older children competently use pencils and crayons and younger children use their fingers to make marks in the sand.

## Personal development, behaviour and welfare are good

Children and their families are warmly welcomed by the manager and staff. There is a very good key-person system in place. This enables children to build close relationships with familiar and trusted adults and supports their emotional well-being. Staff interact with babies in a calm and reassuring way, staying close and offering support when needed. Children's behaviour is good. Staff consistently reinforce rules and praise children who make good choices, which helps them to have a clear understanding of behavioural expectations and boundaries. Children learn about a healthy lifestyle through the provision of healthy meals and plenty of fresh air and exercise. They enjoy a varied range of nutritious meals and snacks which is freshly prepared at the nursery.

## **Outcomes for children are good**

Children of all abilities achieve well and thoroughly enjoy their time at the nursery. Staff provide a highly stimulating environment, which helps children to explore new things, practise new skills, and follow their own interests. Children are eager to take part and motivated to learn. They are very well behaved, friendly and demonstrate good manners. From a young age, children develop confidence and independence, preparing them well for their future learning and eventual move on to school.

Boys & Girls Nursery (Croxley Green) Ltd registered in 2012. It is one of four nurseries owned and managed by the provider. The nursery employs 25 members of childcare staff. Of these, 14 hold appropriate early years qualifications at level 2 or above. The nursery opens from Monday to Friday all year round. Sessions are from 7am until 7pm. The nursery provides funded early education for two-, three- and four-year-old children. It supports children who speak English as an additional language and children who have special educational needs and/or disabilities.
