Summary of key findings for parents

This provision is good

- The childminder is committed to her role and ensures that children receive a high standard of care and learning. She has successfully addressed all the actions and recommendations raised at her last inspection and made significant improvements.
- The childminder gets to know children very well and follows their individual interests closely. She completes regular observations of children as they play, using this information to plan activities that help to promote their development.
- Children are very happy and settled in the childminder's warm and welcoming home. They make independent choices from a good range of toys and resources that is readily available. They are curious and demonstrate good attitudes to learning.
- The childminder uses knowledge gained from recent training to share with parents. This helps to provide consistency of care, particularly when finding strategies to manage children's behaviour. The childminder sets a positive model of behaviour for children to follow. Children behave well, share and take turns.
- Partnerships with parents are very positive. The childminder shares regular two-way information with parents and keeps them well informed about their child's good progress. Parents speak very highly of the childminder.

It is not yet outstanding because:

The new systems that are used to carry out assessments of children's learning are not yet deeply embedded to help support children to make outstanding progress.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

embed assessment systems further, so that children are supported to make even higher levels of progress.

Inspection activities

- The inspector looked at the areas of the premises that are used for childminding, including the outdoor area.
- The inspector observed the quality of teaching during activities indoors and assessed the impact this has on children's learning.
- The inspector completed an evaluation of an activity with the childminder.
- The inspector discussed self-evaluation, risk assessments and the childminder's policies and procedures. She checked evidence of the suitability of the childminder and other adults living and working on the premises.
- The inspector spoke with the childminder and children during the inspection. She took account of the views of parents from written feedback they had provided.

Inspection findings

Effectiveness of the leadership and management is good

The childminder demonstrates a positive attitude to continual improvement. She seeks the views of children and parents regularly and uses these to make changes to her practice. The childminder makes good use of support from local authority professionals to help develop her provision. She supervises her assistants well and ensures that they attend training to help improve their skills. The childminder also ensures that her assistants are aware of the good policies and procedures in place that are used to help keep children safe. When the childminder works with an assistant, she ensures that children are allocated a key person to meet their needs effectively. The childminder ensures that ratios are adhered to and children are kept safe. Safeguarding is effective. The childminder knows what to do should she have any concerns about a child's welfare. She makes sure her knowledge of child protection is kept up to date.

Quality of teaching, learning and assessment is good

The childminder helps children to develop their social skills and confidence very well. For example, she provides activities that support very young children in building new relationships. The childminder skilfully encourages them to take turns in social interaction. She maintains eye contact with young children and recites new words to them repeatedly. Young children enjoy babbling and copying the new words that the childminder introduces and delight in the ample praise given. This also helps children to develop and build on their early speaking skills effectively. The childminder promotes children's interests well. For example, she gets down to their level and models using musical instruments. Young children enjoy shaking the instruments and move their bodies in time to music, copying the childminder's actions. This helps young children to learn how to express themselves and helps to promote their creative skills.

Personal development, behaviour and welfare are good

Children form strong attachments to the childminder. Young children develop good physical skills, such as when they crawl and pull themselves up to stand. The childminder promotes children's healthy lifestyles well. For instance, she takes children to local parks to play each day and provides nutritious, home-cooked meals. The childminder pays particular attention to those children with allergies to help her to effectively support their individual needs.

Outcomes for children are good

All children make good progress from when they first start at the setting. Young children discover how their actions influence the resources they play with. For example, they bang instruments together to hear sounds. Young children enjoy filling and emptying baskets and draw adults into their self-chosen play. They manage their self-care skills well, such as when they feed themselves at an early age. Children gain the skills they need in readiness for the next stage in their learning and their eventual move to school.
