Summary of key findings for parents

This provision is good

- The childminder is very experienced and has a secure knowledge of the early years foundation stage. Children are enthusiastic to learn and make good progress. They develop the skills they need for their eventual move on to school or the next stage in their learning.
- Children develop good communication and language skills. The childminder engages them in meaningful discussions, models clear vocabulary and links their play to real-life experiences to successfully build on these communication skills.
- The childminder accesses relevant training suitable to her role. She uses her knowledge to effectively promote children's learning and development from the outset.
- The childminder builds good partnerships with parents, who report in written testimonials of their appreciation of the childcare service she provides.
- Children's behaviour is good. The childminder is a good role model for children. She teaches them to be kind, considerate and how to use good manners.

It is not yet outstanding because:

- Sometimes, the childminder does not share sufficient information with other settings that children attend in order to help provide a consistent approach to children's care, learning and development.
- The childminder does not consistently encourage children to develop further, their early writing skills.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- develop secure partnerships with other early years settings that children also attend to support continuity of learning
- continue to extend opportunities for children to practise their early writing.

- The inspector spoke with the childminder and children at suitable times throughout the inspection.
- The inspector looked at a range of documentation, including the suitability of those living or working on the premises and children's learning and development records.
- The inspector observed children at play.
- The inspector and the childminder evaluated the effectiveness of an activity.
- The inspector discussed how the childminder reflects on her own practice.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder is fully aware of the categories of abuse and neglect and what would give her cause for concern about a child's welfare. She understands her responsibility to refer her concerns on to the relevant authorities. The childminder ensures her premises is safe and secure for children to play and learn in. She successfully implements a wide range of written policies and procedures and shares these with parents, helping to maintain children's welfare. The childminder reflects on her own practice and identifies ways to continually make improvements to the quality of her service.

Quality of teaching, learning and assessment is good

She regularly observes and assesses children to monitor their ongoing progress and to swiftly close any gaps in their development. This also helps her to identify what children need to learn next. The childminder provides parents with good detail about their child's day and of their progress to help them continue their child's learning at home. She clearly understands the different ways children learn. The activities she provides are unhurried and give children plenty of time to repeat and practise new skills. She skilfully supports children's learning while giving them opportunities to lead their own play. For example, children experiment how they can position play figures into a variety of wheeled vehicles of different sizes. Children thoroughly enjoy engaging in a wide range of imaginative games and activities. For example, as they set up the farm and make fields and pens for the animals.

Personal development, behaviour and welfare are good

Children form very secure bonds with the childminder who is very responsive, kind and caring. The childminder supports children's welfare, and parents' wishes, well. For example, she recognises that young children's care needs vary from day to day and discusses these with parents daily. Children gain a good awareness of healthy lifestyles. They take part in regular physical outdoor exercise, for example, playing in the garden and outings to the local parks.

Outcomes for children are good

Children settle in easily and respond positively to the childminder's encouragement. They are confident and have enthusiasm and motivation for learning. Children show increasing levels of independence. For example, when they choose and access their own toys and resources or when helping themselves to a drink. They engage and focus well during their play, showing great enjoyment in their achievements. Children develop a love of rhymes, songs and books to help support their early literacy skills.
