Summary of key findings for parents

This provision is inadequate

- Staff have a poor knowledge and understanding of safeguarding. Not all staff have a secure awareness of the signs and symptoms that a child may be at risk of harm, including from extreme views and behaviours. In addition staff are not confident in the referral process to follow if they have concerns about a child's welfare.
- The manager fails to implement the nursery's policy for the use of mobile phones and uses her mobile phone when children are present. Not all daily attendance entries are a true reflection of when the children arrive, which compromises children's safety.
- Children's health and well-being are compromised. Staff fail to ensure children have their hands washed prior to eating. They do not take sufficient action to prevent younger children eating food which has been on the floor used for play.
- The quality of teaching is variable. Some staff's teaching practice is poor and does not help children make good progress. Not all staff interact with children purposefully. Although staff observe and track children's development, they do not act swiftly on gaps in development, which hinders children's learning. Managers do not effectively monitor progress to improve outcomes for children.
- The management team fails to monitor practice and identify weaknesses and breaches of requirements. It does not ensure that all staff have appropriate support, supervision and training to fulfil their roles and responsibilities.
- Staff do not consistently help children to develop their independence skills.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. Some staff have a poor understanding of the signs, symptoms and referral procedures to follow in the event of a child protection concern, which puts children at risk. Not all staff have had safeguarding training, despite them working at the nursery for over a year. The nursery has a policy for the non-use of mobile phones. However the manager was seen using her personal mobile phone, which has access to the internet, in a room when working with children. Although staff have registers to record children's attendance, not all entries are entered as children arrive. Staff incorrectly record children's arrival later in the morning, which does not meet the requirements. The manager provides staff with supervision, appraisals and training, but fails to use these effectively. She does not ensure that staff use their teaching skills effectively to support children's learning. Procedures for monitoring children's progress and evaluation of the nursery are weak and the leaders have failed to identify weaknesses in the provision.

Quality of teaching, learning and assessment is inadequate

Staff are well qualified. However, not all children receive adequate support from staff, especially in the pre-school room. Children in the pre-school are not all motivated to learn and are fluctuating in their development and not making adequate progress. The quality of teaching in this room is variable and too often children are ignored when speaking. For example, in a group activity children are ignored when they correctly answer questions about the weather. Staff often do not respond to children's interests. For example, when a low-flying helicopter came past, children excitedly called staff to show them; however, they were ignored. Despite this, some teaching is pleasant. For example, children in the younger rooms have fun exploring with arts and crafts. Furthermore, younger pre-school toddlers enjoy investigating with musical instruments, and some pre-school children benefit from small-group times when they learn about numbers as they play an elephant game with staff.

Personal development, behaviour and welfare are inadequate

Children's well-being is compromised by weaknesses in safeguarding practice. Furthermore, hygiene measures are inadequate and children's health is put at risk. Staff fail to ensure children have clean hands before eating snacks. For example, babies are given a pre-dinner snack on the floor without having their hands washed and pre-school children eat their snack outside after exploring in the forest-school area. Children's health is further compromised as younger pre-school children are seen drinking from other children's water bottles, and toddlers and babies eat crushed-up cornflakes from the floor which have been trodden in by staff and children in their outside shoes. Staff manage children's behaviour appropriately and children receive praise which helps boost their self-confidence. Staff occasionally encourage children to take some risks. For example, they encourage children to climb and take steps to move up the stairs to the slide. Parents talk positively about the nursery and how settled their children are.

Outcomes for children are inadequate

Children do not make the progress they are capable of, or gain the skills they need for their future learning, particularly older children. On too many occasions older children are left to their own devices without any purposeful interaction or support and wander around aimlessly. Some children enjoy playing with their friends and have a good time outside. For example, pre-school children enjoy digging in the mud kitchen. Toddlers have fun mimicking sounds staff make as they chase a football. Babies have their walking skills encouraged as they hold their key person's hand and walk around. This helps to support the children's physical development. However, not all play is enjoyable because staff miss too many opportunities to challenge and extend all children's learning. For example, staff are too quick to do things for the children, such as putting on coats and shoes for the children rather than supporting their independence skills.

Stepping Stones Nursery School re-registered in 2015. It is based in the village of Froxfield. The nursery operates from 7.45am to 6pm from Monday to Friday all year round. The nursery receives funding for the provision of free early education to children aged two, three and four years. The children have access to open-plan rooms with free flow to enclosed outside play areas. The children also have access to a playing field with an outside classroom, a large playground with play equipment and an enclosed woodland area with mud kitchens. There are 12 staff working with the children. Of these, nine staff, including the manager, hold suitable early years childcare qualifications.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
