Summary of key findings for parents

This provision is inadequate

- The leadership and management of the club are weak and there are poor systems for checking the quality of the provision. This results in a number of breaches in statutory requirements.
- Children's safety and welfare are compromised. Systems for determining staff's suitability and for ensuring their continued suitability are ineffective. Managers do not conduct supervision sessions to promote and continually raise the quality of staff practice.
- Children are not safeguarded. Staff have a poor understanding of child protection issues. Policies and procedures are not in line with the Local Safeguarding Children Board requirements.
- The manager has failed to ensure that at least one member of staff holds an appropriate paediatric first-aid qualification.
- Children's hours of attendance are not recorded accurately. In addition, information about who has parental responsibility for children is not obtained.
- The club manager has a poor understanding of Ofsted's notification requirements and has failed to notify Ofsted of a significant event.
- Records relating to children's accidents, injuries and medication are not recorded in a way that ensures confidentiality.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is not effective. The manager has failed to ensure that staff have been subject to appropriate checks to determine their suitability. There are no records of the required identity and suitability checks for staff working at the club. In addition, staff are not asked to disclose any information that may impact on their suitability. Furthermore, staff are unaware that they have a responsibility to continue to do this during their employment. Children's safety and welfare are compromised. The child protection policy is not in line with the Local Safeguarding Children Board requirements. Some staff are unable to identify possible signs of abuse or neglect, specifically where children may be at risk of harm from extreme behaviours and views. They are also unaware of some external reporting procedures. The manager has a poor understanding of the statutory requirements. She is unaware that she must ensure at least one member of staff holds a relevant paediatric first-aid qualification and has failed to ensure this. She has a particularly weak understanding of the notification requirements to Ofsted. Consequently, Ofsted has not been notified of a significant change to the persons making up the registered body of the club. Poor organisation of the club has resulted in weaknesses that affect children's safety and welfare. For example, records containing sensitive information about individual children are not maintained confidentially. In addition, required information about who has parental responsibility for children is not obtained and staff do not record children's hours of attendance appropriately. Reflection on the quality of provision is not robust and managers have failed to maintain the quality of the club. Weaknesses in staff's understanding of their safeguarding responsibilities and poor supervision and vetting procedures mean that children's welfare is not fully supported.

Quality of teaching, learning and assessment requires improvement

Staff use their experience and skills effectively to provide a warm, welcoming and homely environment. Overall, they provide a suitable range of enjoyable activities for children of all ages. Staff support children's developing mathematical skills well. For example, they encourage children to count how many children are present for snack time and set out the correct number of plates they will need. Children communicate effectively, show good listening skills and follow instructions. Partnership working with parents and the school teachers contributes to supporting children's progress and helps to promote continuity in their care. For example, children's emerging understanding of phonics is complemented as they practise writing the letters they are learning about at school.

Personal development, behaviour and welfare are inadequate

Breaches of the statutory requirements affect children's ability to learn and develop in a safe environment. That said, children are motivated and confident to contribute their ideas during group discussions. They say their favourite thing is playing games with their friends. Children behave well and play together cooperatively. They take turns and happily share resources. Older children encourage their younger friends to join in with their play. Children show that they are comfortable with staff and are building positive attachments to their key person. They are confident to ask for items they need and initiate conversations with staff. Children develop a sound understanding of maintaining a healthy

lifestyle. Staff talk to them about the benefits of eating healthily and taking part in regular exercise. Children are encouraged to make independent choices about what they would like to eat at snack time and where they play. This helps children to develop important skills for their future.

Funky Friends Link Club registered in 2010. The club employs two members of childcare staff. One of whom holds an appropriate early years qualification at level 3. It is open Monday to Friday during school term time, from 7.45am to 9am and 3.15pm to 6pm, and during the school holidays from 7.45am to 5.30pm.
