## Summary of key findings for parents

### The provision meets requirements

- The childminder understands her responsibilities to safeguard children, such as reporting any child protection concerns to appropriate agencies, supervising children and ensuring her home is safe.
- The childminder understands the importance of creating a welcoming environment. She has toys, equipment and resources to meet the learning needs of different age groups of children.
- The childminder knows how to use observation and assessments to effectively plan for children's individual needs.
- The childminder understands the importance of promoting children's physical development and a healthy lifestyle, and supporting children's growing independence.
- The childminder understands the importance of developing partnerships with parents and other professionals to ensure the continuity of children's care and learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## Inspection activities

- The inspector talked with the childminder about her knowledge of the learning and development requirements, including arrangements for assessing children's progress.
- The inspector sampled a range of documents and discussed the records and policies the childminder uses for childminding.
- The inspector discussed the childminder's understanding of how to keep children safe.
- The inspector checked the spaces and range of resources used for childminding purposes, and discussed the evaluations that the childminder uses to plan for improvements.

The childminder registered in 2001. She lives in the Hucclecote area of Gloucester. The childminder provides care before and after school during term time. The childminder holds a relevant qualification in early years at level 3.
