Summary of key findings for parents

This provision is good

- The manager provides effective support to help staff reflect on their practice and improve their professional skills further. A thorough and effective induction programme is in place for new staff. The manager ensures they understand their responsibilities as well as the policies and procedures.
- Children enjoy the many opportunities to practise their physical skills. They eagerly explore the equipment, learn to travel up and down safely and negotiate obstacles.
- Staff are skilled in helping children's communication and language development. For example, they use clear language to help babies learn new words and phrases and respond positively to babies' sounds and gestures.
- An effective key-person system helps children to develop close bonds with the nurturing staff. Staff gather detailed information from parents which helps them to plan for children's individual needs. Children new to the setting settle quickly. They are happy, ready to learn and progress well.

It is not yet outstanding because:

- At times, staff do not recognise occasions where children need more time to explore in their own way to develop their thinking skills further.
- Staff do not consider how to make the best use of the outdoor provision to support children's learning as fully as possible.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- increase opportunities for children to investigate and test ideas for themselves to enhance their learning even further
- extend further the learning opportunities for children who learn best outdoors to help them make even better progress.

Inspection activities

- The inspector observed teaching practices and the impact these have on children's learning.
- The inspector held discussions with the manager, staff, children and parents.
- The inspector read some of the setting's documentation, including the safeguarding policy and procedures.
- The inspector looked at a sample of children's development information and records.
- The inspector carried out joint observations with the manager.

Inspection findings

Effectiveness of the leadership and management is good

The manager reviews the provision effectively to improve practice and focuses on improving outcomes for children. Staff work well in partnership with other settings children attend to maintain a continuous approach to their care and learning. The manager and staff monitor children's progress well. They work closely with other professionals to ensure that children who have special educational needs and/or disabilities are well supported and helped to close gaps in their development. Staff keep parents well informed of their children's learning and partnerships are strong. Safeguarding is effective. Staff attend safeguarding training and have a good understanding of how to respond to child protection concerns. The manager ensures children are always supervised by well-qualified staff and correct staffing ratios are followed.

Quality of teaching, learning and assessment is good

Staff help children to deepen their understanding of the world. Children learn to operate toys, such as those with wind-up mechanisms. Babies are motivated to observe their reflections in mirrors and show an interest in the photographs of people displayed. Children enjoy using their imaginations in kitchen role play and make links with their own experiences. They focus well as they play with farmyard animals and help to build shelters for them. Staff help older children extend their mathematical understanding and literacy skills. For example, children are keen to find keys labelled with letters to open the matching lock and staff encourage them to use their counting skills.

Personal development, behaviour and welfare are good

Staff are positive role models and effectively help children to learn the routines and expectations, such as sitting at the table to eat their meals. They learn the importance of good hygiene and wash their hands after handling materials, such as straw, and before mealtimes. Staff encourage children to be independent during everyday routines. For example, babies lift their legs to help with dressing during nappy changing and learn to feed themselves using cutlery. Children enjoy nutritious meals, snacks and drinks, and staff make adjustments to meet children's individual dietary requirements.

Outcomes for children are good

Children progress well with their communication and language development. Babies are keen to practise new sounds, copy words they hear and use gestures. They communicate their wishes and needs clearly and show a good understanding. For example, babies respond quickly to instructions to hold hands as they line up and travel sensibly around the setting. Children develop good social skills and enjoy the company of both adults and their friends. They show an interest in the activities other children are engaged in and are keen to join them. They gain a secure foundation for their future learning.

It operates Monday to Friday from 7.30 am to 6pm, all year except for bank holidays and a week at Christmas. The setting receives funding to provide free early education for two-, three-and four-year-old children.
