# Summary of key findings for parents

#### This provision is inadequate

- The provider does not implement effective recruitment procedures. She does not carry out all the relevant checks to ensure staff's suitability to work with children.
- Some staff do not have sufficient understanding of the nursery's safeguarding procedures or 'Prevent' duty. This compromises children's welfare.
- The monitoring of staff's practice is inconsistent. Some staff do not spend enough time actively engaging with the children. Staff do not make good use of assessments to identify children's next steps and enable them to offer challenge and extend children's abilities to help them make good progress.
- Staff do not encourage children's communication and language skills sufficiently well, particularly children who speak English as an additional language. Staff do not consistently help children to learn to be independent.
- The provider does not make the best use of the outdoor environment. This restricts children in their play and in their ability to make good progress, in particular those who learn best outdoors.
- The provider does not use self-evaluation effectively to identify possible breaches in requirements and target all weaknesses to improve outcomes for all children.

### It has the following strengths

Staff understand the key-person role and help children to settle, form close attachments and feel secure.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider does not make sure recruitment and vetting procedures are secure. She does not take appropriate steps to gather all relevant information to confirm staff's suitability. Staff do not know how to respond should allegations be made about staff members. They understand the possible signs that a child may be at risk of extreme views or behaviour. These weaknesses compromise children's safety. The provider's system for monitoring staff's practice is variable. Although staff have attended some training courses, and goals for their professional development have been agreed, weaknesses in practice are not identified to raise the quality of teaching and learning to a good standard. The self-evaluation process does not identify all areas for improvement effectively. Staff know the arrangements for dealing with accidents and incidents to children and most hold first-aid certificates. They carry out risk assessments to identify and minimise possible hazards to children. Staff are deployed suitably so that ratios are maintained and children are supervised at all times. Partnerships with parents are positive. The parents spoken to at the inspection comment that staff are friendly, caring and keep them informed about their children's routine care and development.

#### Quality of teaching, learning and assessment is inadequate

Staff do not use their observation and assessment processes to plan activities that help children make good progress in their learning. They do not provide suitable levels of interaction and support for children to be involved in their play or help them explore new experiences. On these occasions, children quickly lose interest because they are not engaged. Staff do not provide opportunities during activities and daily routines to help children develop their language skills effectively. For example, staff who speak the same language as the children consistently talk to them in their home language. This does not support these children to learn to understand or speak English to help them in preparation for when they move to school. Nevertheless, young children enjoy looking at books and turning the pages, and older children recognise and name simple shapes.

#### Personal development, behaviour and welfare are inadequate

The weaknesses in leadership and management put children at risk. Staff do not make the best use of the outdoor environment. They do not plan activities for those children who prefer to play and learn outside. Staff do not support children's independence well. On occasions, they do not encourage children to do things for themselves. Staff who prepare and cook meals hold a valid training certificate in food and hygiene. Children receive nutritious meals that meet their dietary requirements and food preferences. Children have regular opportunities to play outside in the fresh air and practise their physical skills.

#### **Outcomes for children are inadequate**

Weaknesses in teaching mean that children do not make sufficient progress in their learning and development from their starting points. Some children are not developing good communication and language skills. Children do not have enough opportunities to develop their independence. Nevertheless, children enjoy pretend play and young children are beginning to develop their early literacy skills. Overall, children are developing some of the basic skills to support the next stage in their development and in readiness for school.

Alphabet Lanes (Berridge Road) registered in 2016. It is one of two settings owned by the same provider. The nursery opens Monday to Friday from 7.15am to 6.15pm, for 50 weeks of the year. The provider is in receipt of funding for free early education for children age two and three years. The provider employs six staff, all of whom hold early years qualifications at level 3 or above.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
