- The childminder knows how to identify and address any risks in her home through completion of a comprehensive risk assessment. She has put measures into place to minimise hazards and ensure all areas of her home are safe and suitable for children.
- The childminder understands the importance of creating a warm and welcoming environment for children. She knows how to help children develop independence, health awareness, confidence and good social skills. She has clear strategies to follow to positively manage their behaviour and knows how to provide healthy, nutritious food.
- The childminder understands the importance of working in partnership with parents.
- The childminder clearly understands how children learn. She knows how to support children's progress by using information gathered through observations.
- The childminder is aware that self-evaluation contributes towards improving outcomes for children. She is able to identify her strengths and areas she wants to improve.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
