## Summary of key findings for parents

## This provision is outstanding

- The management team rigorously evaluates, reflects, and makes changes to constantly improve the quality of the nursery. It uses its expert knowledge and experience in addition to the views of staff, children and parents.
- The enthusiastic staff consistently use skilful questioning to extend children's thinking skills and encourage their learning. The quality of teaching is very strong.
- All children make excellent progress. The manager and staff have high expectations for children. Staff provide sensitive support and encouragement. They adapt to children's individual learning styles and work closely with parents and other professionals to assess and narrow any gaps in learning.
- Children are exceptionally happy and settle very quickly. They benefit greatly from a rich variety of activities, resources and freedom to explore new experiences. They develop extremely positive attitudes to learning, showing high levels of self-awareness and independence.
- Children develop the self-confidence they need to help them in new environments. For example, they are well prepared for changes, such as moving rooms or moving on to school.
- Children are inspired to engage, explore and extend their learning in a happy nurturing environment.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

■ review and improve how staff organise the after-lunch routine in the baby room.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

The highly experienced management team has greatly enhanced the style of teaching used throughout the nursery. Staff are exceptionally well supported and benefit from highly effective role modelling, mentoring and supervision. They are actively supported to develop their skills, enabling them to remain highly motivated and forward thinking. Safeguarding is effective. Risk assessing is thorough and all staff know what to do if they have a concern about a child. Partnerships with parents are excellent. Parents report they are made very welcome. They are kept well informed about their children's activities and progress. Staff are interested in the children's activities at home and share advice. For example, one parent welcomed guidance about their child's sleep pattern.

## Quality of teaching, learning and assessment is outstanding

Staff get to know children exceptionally well. They build on children's interests and ensure resources are easily accessible to support and extend learning. Children develop their natural curiosity and ability to experiment and question. For example, when a child wants a small piece of paper, careful questioning leads to a cutting activity. This inspires other children to join in and learn how to use scissors and carry them safely. Staff skilfully encourage children to develop their communication and language skills. For example, in the toddler room, children excitedly retrieve tactile items from a large bag. Staff model language clearly and extend the children's single words into simple sentences as they describe what they have found.

#### Personal development, behaviour and welfare are outstanding

Children develop an excellent awareness of safe behaviours. For example, they help to risk assess and wear safety goggles as they use the hammer and nails with great care. Children enjoy excellent opportunities to be physically active. For example, babies develop coordination and balance as they travel across different surfaces, climb steps, crawl through tunnels and slide down the low-level slide. Staff teach children about healthy eating and a healthy lifestyle through discussions, exercise and looking at books. They respond to the needs of the children very sensitively and are excellent role models. Staff are very well organised in all rooms. However, the after-lunch routine in the baby room is not currently well established to provide a smooth transition into the afternoon activities.

### **Outcomes for children are outstanding**

Children are articulate and curious, and well prepared for the next stage in their learning. For example, they talk about and explore the size, shape, weight, colour and texture of pumpkins. They become familiar with their senses as they see, touch and smell them, before describing how fresh pumpkin tastes. They learn that pumpkin plants will grow from the seeds and are eager to grow some. They draw pumpkins and practice the finemotor skills that will help them learn to write. They extend their understanding by using books to find information.

Woodberry Day Nursery Ltd - Peartree registered in 2014. It is one of two nurseries owned by Woodberry Day Nursery Ltd. It operates from purpose-built premises in the Bitterne area of Southampton. The nursery is open each weekday for 51 weeks of the year, from 7.30am to 6pm. The nursery is in receipt of funding for the provision of free early education for two-, three- and four-year-olds. The nursery employs 17 members of staff. Of these, two have early years teacher status and eight staff have appropriate early years qualifications. The nursery also employs a cook.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
