The provision meets requirements

- Staff demonstrate a secure understanding of their role and responsibilities for child protection. They are confident in the referral process to maintain children's welfare.
- The manager and management committee know to notify Ofsted of significant events that may affect the running of the setting. Staff demonstrate ways to keep children safe, including teaching them how to manage risks and to play safely.
- Staff understand the importance of working in partnership with school staff and parents. They know how to complement children's learning to maintain continuity of care.
- Staff are aware of how to provide a wide range of activities based on children's choices and interests. They know how to help children learn right from wrong.
- Staff are aware of the significance of self-evaluation and are mindful of the importance of keeping their knowledge up to date to meet the early years requirements. They recognise the importance of building on their knowledge and skills, to help support positive outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Sands End Adventure Project registered in 1996 and is run by a registered charity. It operates from single-storey premises. The provision provides after-school care during term time between 3pm and 6.30pm from Monday to Friday. During the school holidays, the provision is open each weekday between 8am and 6pm. The provision employs six staff, including the manager. Two staff hold level 3 childcare qualifications, three are qualified at level 3 in playwork and one has a qualification in youth work.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
