## Summary of key findings for parents

#### The provision meets requirements

- Leaders and staff know about safeguarding issues. They understand the signs when a child may be at risk of harm and the procedures to follow if they have a concern about a child's welfare.
- Leaders and staff know how to plan activities and offer a wide variety of resources for children's play. They recognise the importance of working in partnership with the host school and parents to complement children's experiences outside of the club.
- Leaders and staff are aware of how to help children understand behaviour expectations. They know how to support children's independence and allow them to make choices about what they want to do in the club.
- Leaders recognise the importance of evaluating their practice to make continued improvements. They know to provide staff with regular supervision and training opportunities.
- Leaders and staff understand the importance of supporting children's good health. They know to provide children with opportunities to play outdoors and be physically active.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector spoke with the leadership team about how it organises the setting.
- The inspector viewed the areas of the premises used when providing care for the children.
- The inspector looked at a range of documentation, including the club's policies and procedures, and recruitment systems, and checked evidence relating to the suitability of staff and committee members.
- The inspector discussed with leaders how they deliver the safeguarding and welfare requirements.

Cool & Crazy Shinfield After School Club registered in 2001. It operates from Shinfield St Mary's C of E Junior School which is located in a residential area of Shinfield, Reading in Berkshire. The after-school club opens during school term times, on Monday to Friday from 3.30pm to 6pm. It employs 19 staff to work with the children. Of these, seven hold appropriate childcare qualifications at level 3 or above.
