Summary of key findings for parents

The provision meets requirements

- The childminder understands her responsibility to safeguard children's welfare. She is knowledgeable about child protection and knows what procedures to follow if she has any concerns. The childminder keeps her knowledge current.
- The childminder understands how to support children's learning and development. She knows how to provide a safe and stimulating learning environment. The childminder has a good range of resources to help her promote children's learning and prepare them to move on to school.
- The childminder knows the importance of monitoring children's progress and seeking additional support for children if necessary. She understands the benefit for children of working with all others involved in their care and learning.
- The childminder knows how to promote a healthy lifestyle and positive behaviour. She understands the importance of teaching children about the diversity of the wider world.
- The childminder seeks views from parents and children to help her plan for ongoing developments and improvements to her setting.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
