Summary of key findings for parents

This provision is good

- The manager, deputy and their staff team have worked hard to address the actions raised at the last inspection. They have worked well with the local authority to improve the quality of the playgroup and raise it to a good standard.
- Staff encourage children to carry out tasks that give them responsibility. Children enjoy gathering their friends for snack time and telling the parents when they are ready for them to come in at the end of the playgroup session.
- Staff interact well with children to motivate them to learn. They show them how to do things, ask questions and explore ideas. This helps children to progress well in their development.
- Staff benefit from regular supervision meetings with the manager. They talk about how they are meeting children's needs and what they need to do to continue to improve.
- Parents are happy with how their child is getting on at the playgroup. They appreciate the discussions with staff when they drop off and collect their child. They receive 'parent pages' which give them ideas of how they can continue their child's learning at home.

It is not yet outstanding because:

- The manager does not yet check the progress of groups of children at the playgroup in order to identify their needs precisely and target additional support.
- Staff miss some opportunities to further support children who speak English as an additional language, for example, when all the children sit together for a discussion or a story.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- extend the monitoring of children's learning to track the achievement of groups of children, identify their needs and target teaching accordingly
- focus more precisely on supporting children who speak English as an additional language to develop their understanding.

Inspection activities

- The inspector observed activities in the playgroup and outdoor area. She assessed the impact activities have on children's learning.
- The inspector spoke to children and staff during the inspection to obtain their views.
- The inspector completed a joint observation with the manager.
- The inspector held meetings with the manager and deputy. She looked at relevant documents and evidence of the suitability of staff working in the nursery.
- The inspector spoke to a number of parents and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

Positive changes have been made to the running of the playgroup. Staff report that monthly meetings with the manager have improved their confidence in their roles. They understand how to assess and plan for children's ongoing learning. Staff complete the progress check for children aged between two and three years and they share this with parents. Training helps staff to develop their knowledge. For example, after attending a course about best practice in the early years, the manager was inspired to develop the inside and outside areas. The manager regularly monitors children's individual learning records to check that staff are consistent in planning for and assessing children's learning. Self-evaluation is accurate. There are action plans in place to help the manager to maintain and continue to improve the quality of the playgroup. The arrangements for safeguarding are effective. Staff understand signs and symptoms that may indicate a child is at risk from harm. They know how to report any concerns about a child's welfare.

Quality of teaching, learning and assessment is good

The quality of teaching has improved to a good level since the last inspection. Staff regularly observe children and carefully plan the next steps in their learning. Children benefit from a range of interesting and fun activities. They develop their hand-to-eye coordination and imagination as they use chunky chalks and glitter to create individual firework pictures. Staff are skilled at helping children to follow their own ideas and encourage them to talk about what they are doing for bonfire night. Children show good concentration as they listen to a story about fireflies and explore the light that their torches make. Outside, children enjoy playing in the sandpit with enthusiastic staff as they make 'ice creams' and count how many different 'flavours' they make.

Personal development, behaviour and welfare are good

Parents say that their children settle in quickly when they start attending the playgroup. They develop good bonds with their key person. Staff offer parents advice about their child's toilet training and sleep patterns. Snack time includes lots of opportunities for learning. Staff help children to name the colours of the peppers that they eat and to recognise the letters in their names as they sit down for their snack. During the playgroup sessions, children can choose whether to play inside or outdoors. They develop their physical skills as they climb the steps to the slide and steer the toy cars. Staff help children to learn about fire safety. They talk about how to stay safe on bonfire night.

Outcomes for children are good

Outcomes for children at the playgroup are good. They learn important skills to prepare them for school. Children develop their confidence to speak to a group as they share their news or show friends a favourite toy. They freely choose their own activities and cooperate with their friends as they play a shopping game together. Older children learn to form letters as they paint the letters from their name. They count confidently to 10 and above as they find out how many children are at the playgroup.

The playgroup opens from Monday to Friday during term time. Sessions are from 9am to 3pm. The playgroup provides funded early education for three- and four-year-old children.
