## Summary of key findings for parents

### The provision meets requirements

- The childminder understands how to use observations and assessments to plan appropriate experiences to meet children's individual learning and development requirements.
- The childminder understands the importance to work in partnership with parents and other professionals, to ensure children are supported in their care and development.
- The childminder knows how to reflect on her service and her own development to bring about improvement. She has taken positive steps to meet previous actions and recommendations to further safeguard children, and work in partnership with Ofsted.
- The childminder understands how to promote and celebrate diversity with children, support children in their personal development, and to develop an understanding of expected behaviour.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector held discussions with the childminder about her understanding of the requirements of the early years foundation stage framework.

- The inspector looked at a range of relevant and required documentation, including policies and procedures shared with parents.
- The inspector discussed with the childminder how she uses self-evaluation to develop her practice.
