Summary of key findings for parents

This provision is good

- The childminder has a good understanding of her role and responsibilities. Her provision is organised and managed well. She monitors the practice of her assistant effectively.
- The childminder offers a welcoming, friendly environment. She works very well with parents to support children's learning, development and well-being.
- Children make good progress from their starting points. The childminder regularly assesses children's progress to ensure any gaps in attainment are quickly identified.
- The childminder provides children with clear guidance about what is appropriate behaviour. Children behave well.
- Children have good opportunities to develop their imagination. For instance, they engage in a wide range of role play activities, such as feeding the dinosaurs and putting them to bed.

It is not yet outstanding because:

- The childminder works well in partnership with parents, although she does not consistently gather information about their views on her setting to help fully inform her improvement plans.
- Although the childminder offers a wide range of resources, she does not provide many opportunities for children to independently explore different technologies in their play.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- enhance the partnerships with parents and gather more information about their views to strengthen monitoring of practice and identify improvements
- provide opportunities for children to independently explore, learn and operate different technologies in their play.

Inspection activities

- The inspector observed the quality of teaching during activities indoors, and outdoors and assessed the impact this has on children's learning.
- The inspector completed a joint evaluation of an activity with the childminder.
- The inspector held a number of discussions with the childminder. She looked at relevant documentation and evidence of the suitability of persons living in the household.
- The inspector spoke to children during the inspection.
- The inspector took account of the views of parents through written feedback provided.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder uses a range of policies and procedures to contribute to the smooth running of her childcare provision and to help keep children safe. The childminder regularly completes risk assessments of her home and for all off-site visits. She understands her role and responsibility to protect children. The childminder is trained in safeguarding and paediatric first aid. She accesses relevant professional development opportunities to build on her existing skills. For example, she has accessed training to increase her knowledge and understanding of tracking children's progress and wants to complete her level 3 qualification in child care, in the near future. Parents provide positive feedback about the quality of the childminder's service.

Quality of teaching, learning and assessment is good

The childminder makes accurate assessments of children's achievements and plans challenging next steps for their learning, considering their interests and developmental stages. The childminder extends children's mathematical development well. She uses every opportunity to refer to colours, shapes and numbers to extend children's learning. For example, she names shapes such as oblong and cube, as the children thread coloured beads onto laces. The childminder supports communication and language development well. She speaks clearly to children repeating new words and provides a constant commentary during the daily routine and activities. Parents are encouraged to extend their child's learning at home. For example, the childminder provides a variety of books they can read at home and extend their child's learning experience.

Personal development, behaviour and welfare are good

The childminder is kind and caring. Children settle quickly and show they are happy as they explore their surroundings with confidence. Children play securely in this stimulating environment. They have daily opportunities for physical exercise outside in the fresh air. They walk to local facilities, such as parks and feed the ducks along the canal and use the equipment and resources in the childminder's garden. Children gain an understanding of people in the wider community and they learn to respect their differences. The childminder promotes the benefits of a healthy lifestyle well. Children eat nutritious and well-balanced meals and snacks freshly prepared by the childminder.

Outcomes for children are good

All children are well prepared for the next stage in their learning. They are motivated, enthusiastic learners who enjoy new challenges and experiences. Children are developing early literacy skills. For example, children sing familiar nursery rhymes and enjoy making marks on the outdoor chalk boards. Children are constantly praised for their achievements. They demonstrate good levels of confidence and self-esteem. They are encouraged to be independent and actively participate in routines, such as tidying away the toys.
