# Summary of key findings for parents

## This provision is inadequate

- The provider fails to ensure that systems used to manage staff's performance are effective and fails to identify weaknesses in staff's teaching practice or in the quality of the provision. As a result, the quality of teaching is not consistent and at times poor.
- Staff do not observe, assess or track children's progress accurately to understand where they are at in their development to enable them to plan to move them on.
- Staff do not support all children's learning adequately, including children learning English as an additional language. Children make insufficient progress, particularly in their language development.
- Staff do not engage effectively with all parents to gain an understanding of children's starting points and to involve them in their children's learning.
- Staff preparing food for children have not received training in food hygiene, as required.
- Self-evaluation is not used effectively to identify and address all weaker areas of practice, to ensure that management and staff are meeting all requirements and improving outcomes for children.

# It has the following strengths

- Children learn to follow suitable hygiene routines and they have regular opportunities to engage in outdoor activities.
- The provider has completed the relevant suitability checks on all staff to ensure they are suitable to work with children.

- The inspector spoke to the manager and staff, and engaged with children at appropriate times during the inspection.
- The inspector looked at various documents, including staff's suitability records, children's files and some written policies and procedures.
- The inspector and the manager jointly observed children and staff as they engaged in activities and discussed the quality of their interactions.
- The inspector took into account the views of parents spoken to on the day.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Leader and managers do not monitor the quality of teaching effectively and this has a significant impact on children's learning and development. Most children come from disadvantaged backgrounds and little is being done to close the gaps in their achievements. Although there are some professional development opportunities for staff, leaders and managers are not focused on improving weaker aspects of staff's practice. The nursery has been working closely with the local authority to address weaknesses identified previously. However, practice has declined since the last inspection. Staff do not share accurate information with parents about their children's learning to enable them to continue to support their children at home. Some parents are unaware of who their child's key person is. Safeguarding is effective. Staff have a sound awareness of safeguarding issues and their role and responsibility to take appropriate action should they have a concern about the welfare of a child.

#### Quality of teaching, learning and assessment is inadequate

Staff do not have a secure knowledge of how to promote children's language and communication development. They do not extend children's vocabulary sufficiently to build their language skills. Staff do not observe or assess children effectively to accurately identify where they are in their learning, to enable them to tailor activities to help each child make the progress of which they are capable. Staff plan the learning environment to provide some suitable activities and experiences for children. For example, children have opportunities to engage in messy activities, such as gluing and sand play, and they have regular opportunities to engage in outdoor activities.

### Personal development, behaviour and welfare are inadequate

The weaknesses in the quality of teaching have a significant impact on children's personal development. Each child has a key person to support them to settle and they build relationships with staff and each other. However, children's social skills are affected by the limited progress they make in their communication and language development. Children are well behaved and play cooperatively alongside each other. Staff preparing meals do not have appropriate training as required, although the manager does. She ensures staff follow appropriate hygiene practices so that children's health is not compromised. The provider has increased the number of qualified first aiders throughout the nursery to ensure they can respond to any accidents or emergencies. Children have regular opportunities to engage in outdoor activities and learn to follow appropriate hygiene routines, such as washing their hands before eating and after using the toilet.

#### **Outcomes for children are inadequate**

Children do not gain sufficient skills to prepare them for their future learning. They do not engage in conversations and some have difficulty verbalising and sharing their ideas. Children demonstrate some independence and physical skills, such as when they try to serve themselves at mealtimes, practise pedalling bicycles and run around in the outdoor environment.

Step by Step Nursery registered in 2007. It is one of two private nurseries owned by Nelson Child Care Limited. The nursery is located in the London Borough of Hammersmith and Fulham. The nursery opens Monday to Friday from 8am until 6pm, for 51 weeks of the year. The provider employs four members of staff, including the manager. Three staff hold relevant childcare qualifications ranging from level 2 to level 6. The nursery receives funding for the provision of free early education for two-, three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
