### Summary of key findings for parents

#### The provision meets requirements

- The childminder maintains a programme of professional development to keep her knowledge of early years practice up to date.
- The childminder has attended recent training to update her knowledge of child protection issues. She is aware of how to report any concerns about children's welfare.
- The childminder understands how to plan for children's learning. She discusses how she intends to build on their interests and use documentation to help her to identify and assess children's next steps in learning.
- The childminder understands how to support children who have special educational needs and/or disabilities. She explains how she would use her prior experience to support children's individual needs in the future.
- The childminder uses menus and discussion to explain how she intends to provide children with healthy meals and support their good health.
- The childminder understands the importance of creating a welcoming and inclusive provision. She talks about how she would build children's confidence and self-esteem.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector discussed with the provider, how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the provider plans to use when caring for children.
- The inspector confirmed there was evidence of the suitability of the childminder and household members by looking at the Disclosure and Barring Service checks.
- The inspector observed the areas used for childminding and discussed arrangements for keeping children safe.
