# Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The provider has failed to provide Ofsted with the information needed to check the suitability of all committee members.
- At times, staff do not organise large-group activities as effectively as possible, to help all children to remain fully engaged in learning.

## It has the following strengths

- Overall, the quality of teaching is good and children make good progress. Staff offer a broad range of interesting activities that motivate children to learn. Staff are attentive and offer individual support to challenge and improve children's learning.
- Staff support children's language and communication skills particularly well. They engage children in conversations throughout the session and effectively model language as children play. Children confidently share their thoughts and ideas and delight in recalling events from home.
- The manager and staff establish strong partnerships with parents. Parents speak very highly of the setting and the care and attention their children receive. Staff share details of children's progress regularly and help parents to extend their children's learning at home.
- The manager values the views of parents, staff and other professionals to help her reflect on the quality of the provision. She involves them in the development of the setting, to help drive continual improvements that benefit the outcomes for children.

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

The provider has not informed Ofsted of all current committee members. Consequently, Ofsted has not been able to establish if all persons responsible for the pre-school are safe and suitable for their role. However, the provider has obtained Disclosure and Barring Service checks for each of them and they do not have unsupervised access to children. This minimises any risks to children's welfare. Rigorous recruitment and induction procedures are followed to ensure the suitability of new staff. Safeguarding is effective. Staff are confident about the signs and symptoms to be aware of and the procedures to follow should they have any concerns about a child. The manager supports staff well. She monitors their performance and ensures all staff attend frequent training that helps to improve their teaching skills. For example, through training, staff have improved how they support children's communication skills. The manager works closely with outside agencies and specialists to promptly secure additional support for children where needed.

#### Quality of teaching, learning and assessment is good

Staff observe children closely and use this information well to plan stimulating and challenging activities that reflect the children's interests. They use skilful questioning to extend children's learning and give them time to problem-solve independently. Staff support children's mathematical skills effectively. For instance, children learned about shape and measure as they wrapped presents and confidently counted beyond 20 during a routine activity. Effective monitoring helps staff to ensure that all children, including those for whom the setting receives additional funding, are making good progress from their starting points.

### Personal development, behaviour and welfare are good

Staff use effective strategies to manage behaviour and support children's emotional wellbeing. For instance, they offer children explanations that help them to recognise one another's feelings, and encourage them to resolve conflicts independently. Children behave well and learn to play as part of a group. Staff find innovative ways to extend children's understanding of diversity in the wider world. For example, children have enjoyed a close link with a school in India to learn about lives of children there. Staff support children's physical well-being effectively. For instance, children enjoy accessing the exciting outdoor environment and take part in regular exercise sessions.

#### **Outcomes for children are good**

Children are active learners. They make independent choices within the stimulating environment and enjoy being creative and imaginative. For example, children made presents and directed their own Father Christmas role play. Children learn to become independent, such as putting on their own coats and carrying out small tasks. Children acquire skills that they need for the next stage of their learning, including school.

Counterslip Baptist Church Pre School registered in 2003. The pre-school is open Monday to Thursday from 8.15am until 3.45pm and on Friday from 8.15am to 12.15pm. It operates during term time only. The pre-school receives funding for the provision of free early education to children aged three and four years. The pre-school employs nine members of childcare staff, all of whom hold relevant childcare qualifications at level 3 or above.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
